	It is the grievance of the Applicants that air pollutants emitted by
	the polluting industry of the Respondent No. 5 (Capital Auto
	Rubber Products (P) Ltd.) are in the nature of soot, dust, smoke
	and gaseous substance which by reason of their chemical
	properties tend to cause damage to life saving drugs
	manufactured by them in adjoining pharmaceutical unit. We feel
S 1	tha <mark>t further e</mark> laboration is required as to the chemical or physical
	intermeddling of the alleged air pollutants in the manufacturing of
	life saving drugs which is being done in the pharmaceutical unit of
	the Applicants. The Applicants may, therefore, file an affidavit
	placing on record the elaboration in respect of intermeddling of the
	air pollutants in manufacturing of life saving drugs as stated
	above.
	Meanwhile, the Learned Senior Counsel for the Respondent No.5
	submits that he wants to go through the record which may throw
	light on the controversy in question, and for that purpose some
	more time is required.
	Surprisingly, none is present on behalf of the Respondent No. 3
	(HUDA) who could have rendered valuable assistance in resolving
	the controversy in question. We, therefore, direct the Chairman,

HUDA to depute any Technical Officer sufficiently Senior in rank to remain present before us on the next date, failing which we

would be constrained to take coercive measures.

Haryana State Pollution Control Board shall file report regarding the present status of ambient air quality in the vicinity of the manufacturing unit of the Applicants as well as stack emission qualities while the industries of Respondent No. 5 are in operation at their optimum, on or before the next date. Such exercise shall be undertaken while visiting the premises and inspecting the same.

Liberty is granted to the parties to come forth with any relevant document on the next date.

Copy of the additional affidavit filed by the Applicant shall be supplied to the contesting parties well in advance, preferably a week before.
