<b>Item No. 8 16<sup>th</sup> November, 2015 Order No. 5</b>	<p>Heard.</p> <p>Holding of marriage functions at MTDC resort adjacent to the residential locality pagariya/colony, Aurangabad, according to the Applicant, is the source of nuisance generated as a result of levels of noise exceeding the standard parameters. We had, therefore, issued directions to the MPCB as well as Municipal Commissioner, Aurangabad to place on record the relevant data of noise monitoring and the notification declaring the said area as a silent zone.</p> <p>Ld. Counsel appearing on behalf of MPCB submits that some time is required for placing on record the relevant data. None appears on behalf of the Municipal Commissioner, Aurangabad, despite notice being duly served on his office. We warned the Municipal Commissioner, Aurangabad, in the last order that in the event of his failure to furnish necessary information, we will be unwillingly constrained to Issue Bailable Warrant against him. We, therefore, issue Bailable Warrant in the sum of Rs.10,000/- (ten thousand) against the Municipal Commissioner, Aurangabad in exercise of our powers and in terms of the provision of Section 19(4)(a) of the National Green Tribunal Act, 2010 read with Order XVI Rule 10(3) and Section 151 of Code of Civil Procedure, 1908.
