- 2. It will have GPS fixed in them.
- The scrapping certificate for two vehicles which are diesel vehicle and are more than 10 years old i.e.
 DL1GB 6364 and DL1GB 6366.
- 4. It will be registered only after submitting complete proof of scrapping and dismantling.
- 5. Photograph be furnished showing number plate which is of old and of that new vehicles.

6. The Applicant should not increase height of the vehicle and it should be strictly within the specified/ permissible limit so as to avoid overloading.
