	orders of the NGT are being flouted with impunity and river Beas	
	is being polluted even by the Government Departments.	
	According to him, the Departments are throwing the waste directly	
	into the river, sewage is being discharged into the river and even	
	the solid waste is being dumped on the banks of the river and	
	even into the river. It is also being burnt.	
	Copies of the affidavit has been furnished by the learned	
	Counsel appearing for the Applicant to the Counsel appearing for	

the State and the Counsel appearing for the State clearly stated that they would take immediate action and would put up an action taken report before the Tribunal by the next date of hearing. Whichever persons and officers are found to be responsible including private individuals, their details would be filed along with reports to whom the NGT would issue notice for initiating contempt of court against them and payment of compensation.
