Replies have not been filed by the Respondents, except the Respondent No. 5. Let the pleadings be completed.</p> <p>Perusal of the Inspection Report reveals that the CETP is not being maintained and run in the manner required. We, therefore, issue notice to UPSI IDC as to why they should not be saddled with the environmental compensation for their failure to run CETP properly and causing damage to the environment.</p> <p>It is also the grievance of the applicant that individual industries are not running their primary Effluent Treatment Plants as required and this contributes to the environmental damage.</p> <p>Joint Inspection of the each industrial units shall be conducted by the Joint team comprising of the officers of UPPCB and CPCB and the report regarding condition and efficacy of ETPs installed at each unit along with the recommendations shall be placed before</p>

us on the next date. Copy of the application shall be furnished to the CPCB by the applicant. Learned Counsel appearing on behalf of the CPCB waives service of notice of this order.
