Learned Counsel appearing for the Respondent No. 5 points out that there is typographical error in the report dated 28.7.2015 at para-5, page-86 wherein it is pleaded that "On the other hand, Respondent Nos. 6 to 9 maps are not approved by the authorities....." He submits that this ought to have been typed as follows: 'On the other hand, Respondent Nos. 6 to 9 and the applicants 'B' & 'C's maps are not approved by the authorities......". Let this correction be made in the pleadings and necessary affidavit be filed on record in support of the corrected pleadings.

Learned Counsel appearing for the Respondent Nos. 6, 8, 9 seek time to file replies. No reply has also been filed by Respondent no. 1, 2 & 4. We do not see any reason in granting further time to these respondents. We can only presume there-from that these respondents have nothing to say as regards the factual content of this application.
