Let the Reply specifically dealing with issues raised by the Learned counsel appearing for the Applicant today before the Tribunal be filed within two weeks from today with advance copy to the Learned counsel appearing for Applicant, who may file Rejoinder, if any within one week thereafter.</p> <p>List on 19th February, 2014.</p> <p><u>Original Application No. 171 of 2013</u></p> <p>We have heard the Learned counsel appearing for the parties.</p> <p>Learned counsel appearing for the State of Bihar have already filed the Reply.</p> <p>Learned counsel appearing for the State of Meghalaya submits he would file the Reply during the course of the day. Liberty is granted. Rejoinder thereto within three weeks from today.</p> <p>The Replies on behalf of the various other States have been already filed. Let copies of the Reply be furnished to the Learned counsel appearing for the Applicant who may file Rejoinder thereto within three weeks from today.</p> <p>The Learned counsel appearing for the Uttar Pradesh submits that there is no illegal mining going on in the District Gautam Budh Nagar. He states that the list of the offenders, who have been indulging in the illegal and unauthorized mining from the River bed or otherwise, has been filed.</p>

List was filed on the last date of hearing. Let Notice be issued to all the parties mentioned therein who may have not been served with Notices. These Notices shall be issued for the purposes of providing them an opportunity to show cause as to - why they should not be directed to pay compensation for illegal and unauthorized sand mining causing damage to environment and ecology in the area in question. Registry shall issue Notices to all these person without process fee. All these Noticees shall be served with the Notice by the DSP, Gautam Budh Nagar who is present before the Tribunal today.

Learned counsel appearing for State shall produce Registration Books of all the seized and list of case property in the FIRs registered. This list should be filed within two weeks from today along with the photocopies of the documents.

The list of Leases/Licenses for mining which were issued during the last 10 years be filed. It shall also be stated in the same very document as to how many permits have been issued for what quantity and replenishment capacity of that area for which these permits were issued. Let all the details be positively filed within two weeks from today.

List this matter for directions on 19th February, 2014 as prayed.
