and submits that he would file a complete and comprehensive Affidavit dealing with the various aspects including Hotels and Projects and other commercial activity which are coming up within 10 KM of the boundary of the Kaziranga National Park. He shall also file a list of the such constructions or activity which are offending the distance of 10 KM as contemplated under the orders of the Hon'ble Supreme Court of India.

Learned counsel appearing for the State submits that they have filed an affidavit dated 24th November, 2015 indicating the complete compliance to the order of the Tribunal. Let the Applicant may file response thereto, if any, within two weeks from today with advance copies to the Learned counsel appearing for the parties.

Let this matter be listed before the learned Registrar General at 12.00PM today and all the Noticees would appear before Registrar General. In the order he shall clearly state by name which Noticees have not been served, which Noticees have filed their Replies and which Noticees have not filed their Replies.

Liberty is granted to the Applicant and the State Government to respond to these Replies within one week from today.

List these matters on 09th December, 2015 for directions when the Secretary, State of Assam, Senior Officer from Ministry of Surface and Road Transport and Director of Kaziranga National Park will be present in person.

We have directed the Director of Kaziranga National Park to conduct a surprise inspection of the road abutting Kaziranga National Park and steps that have been taken

by the State of Assam in regard to prevention of animal deaths on the roads by the vehicular traffic.
