## Orders of the Tribunal

Item No.3 11<sup>th</sup> August, 2017 Order No.3 Learned Counsel appearing on behalf of Respondent No.3 – Irrigation Department submits that demarcation of blue line is complete and it is for Respondent No.2 – PMC to act upon the booklet giving longitudes and latitudes with reference to blue line furnished to them vide letter dated 15<sup>th</sup> November, 2016 at Annexure-A collectively.

Learned Counsel appearing on behalf of Respondent No.2 – PMC on instructions from Mr. Machale, Assistant Engineer, Building Department admits that the PMC has received the booklet showing the demarcation of blue line by the Respondent No.3 and the action needs to be taken at the site in that regard. She submits that sometime be granted for visiting the site and taking further steps necessary for the compliance of the Order.

Parties shall assemble at Survey No.119/4, Parvati popularly known as Datar Farms, Pune at about 11.00 A.M. on 23<sup>rd</sup> August, 2017. The Respondent No.3 – Irrigation Department shall depute necessary staff for showing on the site the blue line as per the booklet issued to Respondent No.2 – PMC and give necessary instructions to the Respondent No.2 – PMC as regards the onsite demarcation of the blue line. The Respondent No.2 – PMC shall keep Mr. Machale, Assistant Engineer, Building Department Zone-5 or any other competent officer dealing with removal of

encroachments present at the site to take necessary instructions as regards the blue line from the Respondent No.3 – Irrigation Department. The Applicant and the Respondent No.1 shall cooperate with the officers of the Respondent Nos.2 and 3. Learned Counsel appearing on behalf of Respondent No.3 – Irrigation Department on instructions makes a statement that the Plan at Annexure-I to the application is the same Plan of demarcation of the blue line referred to in the booklet.
