	and unauthorized mining at Parbabar, district Nagore.
	Photographs have been placed on record which shows

E N	According to the applicant the project where that
2	mining is carried on illegally and unauthorizedly, has no
<b>M</b> , 7	environmental clearance obtained by any person
	whatsoever. While the State Government has taken
	stand that mining was carrying on in that area and they
	have not issued any mining lease to any person for that
	particular area. In fact the State Government has filed
	photographs showing the status of the site in question.
	Once both theses photographs of Applicant and
	Respondents compared, there is no difficulty. The State
	has not taken steps to restore the ecology of the area and
	took any precautionary and restorative measures.

07<sup>th</sup> March, 2017 and 25<sup>th</sup> July, 2017, keeping in view the stand taken by the State Government, it was directed that action should be taken against all the erring officers who were posted on that area and permitted to carry on illegal and unauthorized mining.

The Learned Counsel appearing for the State Government submits that action against them has been initiated, charge sheet has been served upon the officials and proceedings are pending. Further, according to him, FIRs have been registered against the unknown persons. Subsequently, according to him, 6 persons were identified and even the penalty has been imposed for carrying on illegal and unauthorized mining which they have paid.

The identified six persons are as follows :-

- 1. Ti<mark>k</mark>am Singh S/<mark>o. M</mark>oti Singh Daroga;
- 2. Devi Singh S/o. Ramdeen Singh;
- 3. Likhama Ram S/o. Chhotu Ram Jat;
- 4. Madusudan S/o. Gopal Saada;

5. Bhawar Singh Daroga S/o. Mohan Singh Daroga and

6. Prakash Nayak S/o. Prasaram Nayak

In light the above we dispose of this application with the following directions:-

- We direct departmental proceedings against all the erring officers and officials be initiated within 6 months from today without delay and default.
- 2. Besides this, what penalty is imposed upon these officials/officers in accordance with law and relevant rules by the Competent Authority, the

authority shall imposed environmental compensation on each of the employees to the extent of Rs. 50,000/- These environmental compensation shall be recovered from the salary of the erring officers/officials in monthly installments.

- 3. The Mining Department and the Rajasthan State Pollution Control Board is hereby directed to recover a sum of Rs. 1 Lakh from each of the persons who were found to be responsible for carrying on illegal and unauthorized mining in this area. Recovery shall be made in accordance with law within four weeks from today. In the event of default thereto the same shall be recovered as arrears of land revenue.
- 4. The amount recovered from the officials/officers and private parties shall be utilized for restoration of the hill and trees in that area within 8 weeks from today.
- 5. A compliance report to this regard be submitted through Secretary, Mining Department before the Tribunal which shall be placed before the Tribunal.

With the above directions Original Application No. 523/2015 stands disposed of. No order as to cost.

This application does not survive for consideration as the main application itself stands disposed of.
