We make it clear that the Delhi Government shall send its proposal to MoEF within 15 days from today. Thereafter, the MoEF shall take appropriate decision after consulting the Governments of Delhi as well as Uttar Pradesh and inform the same before this Tribunal.

We direct the Uttar Pradesh Pollution Control Board (UPPCB) represented through State Government represented by Ms. Savitri Pandey, Advocate and its officials to visit the various projects in respect of the applications received in Form No. 1 situated within the area of 10 km from the Okhla Bird Sanctuary and in respect of which Environment Clearance (EC) has already been granted and report before this Tribunal about the correctness of the various statements given by the Project Proponents in Form No. 1. The said particular shall be furnished by the next date of hearing.

The National Board of Wildlife also, in the meantime, shall also submit its proposal before this Tribunal on next date of hearing.
