We expect the Principal Secretary of the Urban Development Department to call for such Meeting of the Commissioner Pune, the Collector, Solapur and other stake holders at an early date and to take policy decision and also to ensure that appropriate budgetary allocation is made available at the State level as well as at the Central level by obtaining proper funding from Central Government/Planning Commission.

So far as the Respondent No.5 is concerned, Mr. Khurjekar, Learned Counsel seeks leave to file Misc. Application for extension of period for consent to operate and, therefore, desires to file Misc Application today. If such Application is filed today, it may be scheduled for hearing tomorrow at 11.00 O'clock.
