Perused record.</p> <p>While expressing concern for the installation of RWHS in Residential Welfare Association premises vide order dated 14-07-2016, CGWA and DJB were directed to place Status Report in that regard before us. The DJB has accordingly placed the Status Report dated 03-08-2016 before us and CGWA has adopted the same vide order dated 04-08-2016.</p> <p>Learned Counsel appearing on behalf of the DJB submits that DJB has been running the Rain Centers in R. K. Puram, Laj Pat Nagar and Dwarka area of Delhi for propagating the installation of RWHS. She submits that Residential Welfare Associations have taken advantage of these centers and acted upon it. However, for scrutinizing the actions of all the Residential Welfare Associations in Delhi, it is necessary that the complete information i.e. list of Residential Welfare Associations in Delhi be made available to the DJB so as to enable it</p>

to find out how many amongst them have the RWHS and how many do not.

We, therefore, direct the Respondent no. 5 Govt. of NCT of Delhi to furnish a list of Residential Welfare Associations in Delhi registered with Registrar under the Society Registration Act before us. Advance copy of the list be also furnished to the applicant, DJB and CGWA.

List the matter on 22nd September, 2016.
