In the affidavit filed along with the said list of Restaurants, it is stated that the above said 33 Restaurants situated in the Hauz Khas area have installed ETP which are actually in functioning capacity as on date apart from the DG sets which are functioning adequately. It is relevant for the purpose of appreciation of the same to extract the portion of the report which is as follows: Para 6. "That in compliance of the direction as mentioned (c) and (d) above, the detail status report is collectively enclosed herewith as Annexure-R-2/2. It is most respectfully submitted

herewith as Annexure-R-2/2. It is most respectfully submitted that all the 33 restaurants have applied for consent to establish and consent to operate to the answering respondent alongwith all requisite documents including adequacy report and monitoring reports of ETP and DG sets from empanelled consultants of DPCC. As decided in the Consent Management Committee, Consent to establish and consent to operate has been granted to these restaurants. DPCC has issued closure direction to 12 units on 09.01.2014 which have not applied for consent to operate till 07.01.2014. Subsequently, in compliance of directions of this Hon'ble Tribunal, these units applied for consent to operate and therefore, direction of closure was revoked by DPCC."

Inasmuch as, the DPCC having satisfied about the adequacy of the effluent treatment plant having installed the same apart from DG sets and it has also granted consent to operate in accordance with law and are operating as on date, we record the said statement and we hold that nothing survives in so far as the said 33 Restaurants are concerned.

However, we make it clear that the said 33 Restaurants shall continue to maintain ETP and DG sets with the required standards and the DPCC shall make periodical visits so as to ensure continuous compliance of the environmental standards.

We also make it clear that if any new application is received from the Restaurants for the purpose of consent to operate, the DPCC shall pass orders in accordance with law subject to the condition that the ETP as well as DG sets are installed and function in accordance with the required standards and the same is maintained by the concerned Restaurants and the DPCC shall make periodical visits so as to ensure compliance of the environmental standards.

In the meantime, DPCC is also directed to find out that in Hauz Khas area, if there are any Restaurants which are functioning without obtaining consent to operate from the DPCC, appropriate action shall be taken by it in accordance with law and report before this Tribunal on the next date of hearing.

Pursuant to our earlier direction, the Committee constituted by us by order dated 25.09.2013 has filed its report which contains various recommendations and measures to control air and water pollution in respect of Restaurants/Hotels and of Eating Houses situated in the whole of Delhi.

Pursuant to the said recommendations, it is seen that the DPCC has also given public notices in leading newspapers directing that if any person having any objection regarding the report is entitled to approach this Tribunal. It is based on that the National Restaurant Association of India has approached this Tribunal by way of filing an impleadment application which we have allowed. It is also informed to us that the entire report is uploaded on the website of DPCC and any person can have access of the same. We direct all persons who are interested including the Applicant herein as well as all the Respondents to file their response relating to the recommendations made by the Committee constituted by this Tribunal so as to enable this Tribunal to pass a comprehensive order.

It is also informed to us that the National Restaurant Association of India has already given list of Hotels and its members who are owner of various Restaurants/Hotels in Delhi to the DPCC. The DPCC shall take necessary steps to inform about the recommendations of the Committee so as to enable everyone to participate in giving their suggestions for arriving at an appropriate conclusion in respect of all hotels/restaurants/eating houses, etc. situated in Delhi. The National Restaurant Association of India has also agreed to inform about the same to each of its members. Learned Counsel appearing for the newly added party, shall also file response relating to the recommendations made by the Committee constituted by this Tribunal by the next date of hearing.

Since in respect of all 33 restaurants, consent to operate has already been given by the DPCC, M. A. Nos. 863/2013, 927/2013, 928/2013, 934/2013 & 936/2013 are disposed of accordingly. Stand over to 26th March, 2014.
