Date and Remarks	Orders of the Tribunal
<p>Item No. 07 23rd December, 2016</p>	<p>The matter was taken up for consultative hearing in which details regarding sewage in Bhopal were presented. However, we have confined ourselves in the first phase to the untreated sewage coming into Upper Lake.</p> <p>As a first case the point of entry identified to be dealt with is at Shirin Nalla where Ahmdabad pumping house exists. The Commissioner BMC assisted by the Officers submitted that they will present before the Tribunal on 10.01.2017, details of the work which they intend to undertake for interception and diversion of the nallah so that there is zero discharge of untreated waste into the Upper Lake at Shirin Nallah.</p> <p>It was also stated that with a view to reduce the flow into the plant / nallah which also contains treated water from plant existing on the Ahmdabad hills, the treated water from the said plant would be utilised and for that purpose a scheme would be framed for the same.</p> <p>For submitting the details and the planning process parties agreed that the matter may be listed on 10.01.2017.</p>

The Commissioner further stated that for execution of the work at the Ahmdabad pumping house for harnessing the Shirin Nallah and so as to prevent discharge into the Upper Lake a period of 45 days would be required.

As prayed let this matter be listed on **10th January, 2017.**

M.A No. 1098/2016 has been submitted by the Applicant along with the copy of newspaper cutting pointing out that some persons are reportedly constructing a private road parallel to the VIP road in the catchment area of the Upper Lake. Learned Counsel Shri Sachin K.Verma is directed to submit the factual report after taking the same from the concerned SDM / SDO of the area.
