between 2011 and 2013. However, he submits that the UP PCB

would be interested in installation of automatic monitoring stations as suggested by the CPCB and he would be taking instructions in that regard. He further submits that there has been only 18 industries which are presently using coal, pet-coke and wood as a fuel for their industries and steps have been taken to switch over from such fuels to cleaner fuel like PNG/CNG.

However, we feel that the use of wood as a fuel should be dis-continued forthwith. Learned Counsel appearing for the UPPCB submits that steps would be taken to stop use of wood as a fuel in industries forthwith.

Learned Counsel appearing for the UPPCB seeks time for giving its response as to the installation of the automatic monitoring stations as well as possibilities of use of smokeless stacks for the industries and switch over to the technology offering zero discharge of liquid effluent by the industries.

Mr. N.K. Gupta, Sr. Env. Eng., CPCB makes a statement that air monitoring would be carried out within the limits of NOIDA as well as in adjoining areas particularly with reference to the lead content in the area in the first week of October 2014.
