We direct the Secretary, PWD, NCT Delhi would call for a meeting immediately wherein the Joint Commissioner Traffic, the Commissioner North MCD, Officers of the PWD, DDA, CPWD and the market federation would be present and examine the proposal prepared by the traffic police for meeting the congestion of the traffic in Karol Bagh resulting in serious air pollution. We are informed that Corporation is proposing to build a Multi Level Car Parking at Shashtri Park. The Committee may also examine if there is any other space available where Multi Level Car Parking could be built.

In the meanwhile, the traffic police shall completely enforce the Orders of the Tribunal particularly in relation to Karol Bagh, South Extension and Nehru Place.
