Perused.</p> <p>This is an application filed for cancellation of bailable warrants issued against Member Secretary of the State Pollution Control Board (Respondent No. 3) and the District Magistrate, District Rajouri, J &amp; K State (Respondent no. 4) vide order dated 26.05.2014. Bailable warrants were issued against the Respondent Nos. 3 &amp; 4 as none appeared on behalf of the State Pollution Control Board as well as District Magistrate and nothing could therefore be known about the compliance of the earlier directions of this Tribunal, particularly regarding the status report throwing light on the affairs of the brick kiln in the State of J&amp;K.</p> <p>Today, learned Counsel appearing on behalf of the Respondent Nos. 3 &amp; 4 submits that the absence of the Respondent Nos. 3 &amp; 4 before the Tribunal on the last date was for a benofide reason and they shall abide by the directions of this Tribunal and keep the duly instructed Counsel present before the Tribunal to take part in the proceedings from time to time.</p>

Learned Counsel appearing for the Respondent Nos. 3 & 4 submits that the status report along with affidavit of compliance of directions passed by this Tribunal shall be filed within two weeks from today with advance copies to the Applicant, who may file rejoinder, if he desires to do so.

Considering the words of the learned Counsel appearing for Respondent Nos. 3 & 4, theailable warrants issued against them are cancelled. M.A. No. 358/2014 stands disposed of accordingly.
