		Districts in the State of Meghalaya due to adverse weather
		conditions and inaccessibility as stated in the Report.
		In light of the above consideration and fact that the

only six Districts presently, we pass the following directions:-

- The guidelines for transportation of already extracted coal are permitted to be published and circulated.
- 2. It is only the transportation of already extracted coal that is being permitted by this Order. Transportation of the extracted coal shall be strictly in accordance with the guidelines published and the Orders passed by the Tribunal from time to time.
- 3. The Committee may carry on its proceedings further and cover the remaining Districts which have not been covered in the Report under consideration.

The Committee shall also enure its best to expeditiously submit its report to the Tribunal on the aspects of coal mining in the State of Meghalaya as already directed under the Orders of the Tribunal.

The Committee is also directed to examine the mining plan in accordance with the Mining Rules and the schemes formulated by the Central Government in consultation with the State Government and place the same before the Tribunal on the next date of hearing.
