	Item Nos. 13 to 16 February 25, 2016	The Noticees present before the Tribunal jointly pray that the Tribunal should take a lenient view and may not impose Environmental compensation of Rs. 50,000/- as already directed. However, before we can consider this

contention, let the respective Corporation and the Public Authorities file a separate list before us of the builders who are constructing and violating the directions and norms and guidelines issued by the Authorities as well as order of the Tribunal.

We direct that all the public Authorities must concentrate on the builders who are raising huge construction and are emanating lots of dust and other particular matters in the air as a result of not taking appropriate Environmental measures. The list should be filed within two days from today and the list of the Noticees who are present today by the Officers of the respective Corporations. List this matter in relation to above Noticees on 06th April, 2016.
