	Directions for deconcretisation of the base of the trees
	within the limits of Respondent authorities, Gurgaon
A	are solicited in the present application.
j j	Learned Counsel appearing on behalf of the
	respondent nos. 1 to 5 has already made a statement on
	instructions that the work of deconcretisation is under
	way and the same would be completed within 2 months
	and trees would not be misused for anchoring electric
	wires etc. A short reply dated 15.4.2015 filed by
	Assistant Engineer Municipal Corporation of Gurgaon,
	describes the actions taken in that regard.
	It is the apprehension of the Applicant that the
	actions as promised by the authorities would not be
	carried out in totality and for that purpose there should
	be some relief granted to the applicant.
	The Learned Counsel appearing on behalf of the
	respondents submits that the authorities are prepared

to designate their respective officials who may undertake the grievance redressal in the matter of the deconcretisation of trees within their respective limits, and the officials who are proposed to be designated for entertaining the complaints about deconcretisation of the trees are as below:

- 1. For the area under the control of HUDA: SE-I and SE-II, HUDA, Gurgaon
- 2. For the area under the control of Municipal Corporation of Gurgoan: SE, MCG, Gurgoaon
- For the area under the control of Conservator of Forest Department: District Conservator of Forest
  , Gurgoan
- For the area under the control of DHBVN that is Dakshin Haryana Bijli Vitran Nigam: SE
  Operations, Gurgoan

On instructions, he make astatement that anyone having grievance about the concretisation of trees and the action not taken to deconcritise, he or she may approach the respective authorities having control over the area where the trees in question exist and the official designated for that purpose as aforesaid shall be entertaining such complaints and taking conclusive action within a fortnight from the date of making of such complaint.

He further assures us that the description of the designated officer for this purpose shall be put on the website of the concerned department for wide publicity. On instructions further statement is made that the complaints can be lodged on the following website, the cognizance of which will be taken by the respective authorities as assured.

We hope and trust that such mechanism will be in place at the earliest and the action as envisaged will be faithfully taken by the concerned authorities. We therefore, believe that the purpose of this application has been served.

Original Application No. 45/2015 stands disposed of accordingly with no order as to cost. M.A. No. 126/2015 therein also stands disposed of.
