<b>/</b>	15, 19 & 20 read with Section 18 of the National Green Tribunal
	Act, 2010 for taking exception to indiscriminate excavation of soil
	for construction of basement reaching to the depth of 60 feet or so
	and its commercial disposal, and for stay of such activities
	undertaken by the Respondent No. 2 (NBCC Ltd.), and for
	restitution of the said excavated portion of the earth at Kidwai
S .	Nagar East, New Delhi.
	According to the Applicant, he is not challenging the EC
2	granted to the project construction undertaken by the Respondent
	No. 2 (NBCC Ltd.) but taking exception to the act of excavation
	which amounts to mining of soil and the cause of action for the
	same arose on the start of the implementation of the project in
	question. He refers to para-5 of the application as the statement
	made by him in respect of the limitation governing the present
	application. However, we do not find any candid and precise
	statement regarding fact of starting of the implementation of the
	project in question.
	The Applicant in person submits that he would clarify the

said fact precisely by adding to the application specific paragraph

regarding limitation as envisaged under Form-1 prescribed under the National Green Tribunal Practice and Procedure Rules. He seeks liberty for doing so. Liberty is granted.

Necessary amendment to be made by the Applicant forthwith. Issue Notice to the Respondents by registered post/acknowledgment due and Dasti as well upon necessary amendment being made by the Applicant in the application. Learned Counsel appearing on behalf of the Respondent No. 1, 3 & 5 waives service of notice subject to he being furnished with the copy of the amended application. Requisites to be filed within three days from today.
