ORDER

1. Today, none has appeared from the side of applicant despite repeated calls nor had he appeared on the previous date also.

From the side of respondent No.1-Municipal Council, Achalpur, learned counsel Mr. Sangram Singh Bhosale has appeared, who prays for additional time to be allowed to file objection against the Joint Committee Report and to file reply affidavit on the ground that the Government Officers of respondent No.1 are deputed for election duty because of which the same could not be filed. Looking to the genuine reason, we provide four weeks' time to the respondent No.1 to file the same.

3. From the side of respondent No.2-MPCB, learned counsel Ms. Manasi Joshi has appeared, who has sent current status report of the

site in question through e-mail dated 03.05.2023, wherein it is recorded that at present 23,500 MT of legacy waste accumulated at the site in question, out of which 3500 MT has been assured to be cleared by May 2024 and for the remaining legacy waste, they intend to enter into an agreement with the private contractors. It is also mentioned in this report that respondent No.1 has proposed a new site, at Survey No.27 E-Class, Mouje- Khelghumat, Tal. Achalpur, District- Amravati, having an area of 9.16 Hectare for setting up processing site for Solid Waste Management.
