# REPLY ON BEHALF OF RESPONDENT NO.5 IN RESPECT OF PARA NO. 24 & 21

I, Vilas Ghogare, age- 45 years working as Joint Director, Industrial Safety & Health, Thane, Dist.- Thane submitting as under

The Following are the points raised in the O. A. No. 31/2023 with respect to Directorate of Industrial Safety and Health, Mumbai, hence I hereby submitting the reply as under on behalf of Director, Industrial Safety & Health, Mumbai, Maharashtra.

- 1. I say that the Directorate, Industrial Safety and Health, Working under labour department. Government of Maharashtra enforcing The Factories Act, 1948 and the Rules made there under. I have read the Original Application along with its annexure there to and also perused the relevant record maintained by my office with reference to the subject matter of the present Original Application and on the basis of the said record, I am filling this affidavit to the above Original Application.
- 2. I say that regional office of the Respondent 5 is enforcing The Factories, 1948 and Rules made there under. As per the said Act, the office enquires about the accidents, fire, explosion or any dangerous occurrence occurring in the factories.

# 3. Regarding para no. 24 raise in the Original Application

- The name and title M/s. Bharat Serums and Vaccines Limited, 3rd Floor, Liberty Tower, Plot No. K-10, Behind Reliable Plaza, Kalwa Industrial Estate, Airoli, Navi Mumbai, Thane 400 708 is not registered under factories act till date.
- ii. The complaint from the appellant was received to the regional office on 16/11/2022. The complaint was submitted to Director, Industrial Safety and Health, Mumbai for permission of visit. After receipt of complaint from applicant (Annexure-I) regarding operating a factory without obtaining required valid license under the provision of Factories Act 1948, Deputy Director from this office visited the said premises i.e. M/s. Bharat Serums and Vaccines Limited, 3rd Floor, Liberty Tower, Plot No. K-10, Behind Reliable Plaza, Kalwa Industrial Estate, Airoli, Navi Mumbai, Thane 400 708 on 28/11/2022.
- iii. In this premises activity of making of medicines was being carried out. Theses includes such as a. Luprodex 3.75 mg, 11.25 mg, b. Liposomal Amphotericin B injection 50 mg, c. Ceftaroline fosamil powder for infusion

600 mg, d. Certizidime 2 gm and avivactam 0.5 gm powder injection, e. Dydrogesterone tablets 10 gm, f. Anti-T Lymphocyte Immunoglobulin, g. Snake Venom Antiserum, h. Rabies Antiserum, i. Recombinant anti rho d immunoglobulin, j. Recombinant human follicle stimulating hormone, k. Human chorionic gondtropin (recombinant).

- iv. Making of medicines is a "Manufacturing Process" as per section 2(k)(i) of Factories Act 1948. This was been carried out with aid of power in form of electricity and with employing 63 number of workers hence this premise constitute of factory as the manufacturing process was being carried out in this premises with more than 20 workers & with aid of power in the form of electricity.
- v. During visit to the factory it was observed that the occupier of the factory was using the premises as a factory without obtaining a valid license from Director, Directorate of Industrial Safety and Health, Maharashtra State, Mumbai.
- vi. Hence notice (Visit Remarks-Annexure-II and Show Cause Notice-Annexure-III) was issued against occupier for the contraventions of Rule 4(4) and Rule 4 (1) (a, b, c) of Maharashtra Factories Rules, 1963. As no compliance was secured by the occupier, Directorate of Industrial Safety and Health, Thane office has filled prosecution under provisions of Factories Act 1948 against Occupier in the court of Chief Judicial Magistrate Thane, bearing Court Case No S.C.C. 6284/23 on 18/01/2023 for not obtaining factory license for premises located at M/s. BHARAT SERUMS AND VACCINES LIMITED, 3<sup>rd</sup> Floor Liberty Tower, Plot No.K-10 Behind Reliable Plaza Kalwa Industrial Estate, Airoli, Navi Mumbai, Thane-400708. The Case is under trial before Hon. Chief Judicial Magistrate, Thane Court.
- vii. Hence it is not true to say that 'failure of concerned authorities to take action against respondent no.1 industry and their lethargic approach towards addressing issues relating to the environment'; as far as office of Directorate of Industrial Safety & Health, Thane is concerned.

## 4. Regarding para no. 21

 Regarding the factory having name and the address respondent no. 1 Bharat Serums and Vaccines Limited, Located at K-27, K-27/Part, K-27-1, Anand Nagar, MIDC, Ambernath, Dist-Thane - 421506 is registered under the Factories Act 1948. The factory is having license under Factories Act 1948 for 2023. The Occupier had complied the statutory requirements for the issue of the license & renewal under factory act. Hence license cannot be canceled.

Hence I Shri. Vilas Ghogare, Joint Director of Industrial Safety & Health, Thane is submitting the above points with respect to in O. A. No. 31/2023 on behalf of Industrial Safety and Health, Mumbai (Respondent No. 5). I crave leave of this Honorable Tribunal to file additional reply, if so required.

- 2. That for manufacturing the Pharmaceutical products there is requirement of Factory and Research & amp; Development unit having a pilot batch manufacturing plant i.e having mandatory infrastructure & facilities of a factory for manufacturing goods.
- 3. That for pilot manufacturing activities involves power and manpower, Solvents in large quantities, generators, LDO for running Biolers /generators, compressed Nitrogen gas for operating the plant. For your information the company have obtained Consent in red category from Maharashtra Pollution Control Board.
- 4. That for running business of manufacturing of Pharmaceutical products having a R&D Unit with pilot batch manufacturing facilities the Licenseunder The Factories Act 1948 is mandatory requirement and the issuing authority of the said License is The Director / Joint Director of Directorate

  Of Industrial Safety & Director & Covernment in the Maharashtra State.
- 5. That all infrastructure and records are to be Compulsorily provided and maintained as per the provisions of The Factories Act and the Factories Rules strictly.
