The Joint committee status report dated 28.10.2023 in compliance of Hon'ble NGT order dated 13.09.2023 in the matter of OA No. 480 of 2022 titled as Kuldeep Vs State of Haryana.

The Hon'ble NGT vide order dated 13.09.2023 directed that

5. *The Joint Committee is directed to verify the factual position regarding compliance with consent conditions and environmental rules/norms/regulations by all the stone crushers operating in Birhi Kalan Zone and submit its report suggesting remedial measures and to send copies of its report to the concerned Statutory Authorities and also the Project Proponents for remedial action.*

6. *Additional report be filed by the Joint Committee on or before 31.10.2023 by email at judicial-ngt@gov.in preferably in the form of searchable PDF/OCR Supported PDF and not in the form of Image PDF.*

7. *In case of violations the Joint Committee shall also put the concerned violators to notice of the present proceedings pending before this Tribunal with specific direction to appear before this Tribunal on the next date of hearing fixed hereinafter.*

In compliance of NGT order dated 03.11.2022, the joint committee comprising of the SDM, Charkhi Dadri (Representative of Deputy Commissioner, Charkhi Dadri), Dr. Jitender Kumar, Deputy Director, Agriculture Department and Sh. Navneet Bhardwaj, AEE visited the stone crushers of Birhi Kalan, Charkhi Dadri in month of October 2023.

The compliance status of Air Pollution control measures provided on the stone crusher premises as per notification dated 11.05.2016 along with consent to operate status of stone crushing units of Birhi Kalan, Charkhi Dadri are enclosed as **Annexure-A**. Out of **30** nos of stone crushing units located in Birhi Kalan, Charkhi Dadri, **19** nos of stone crushing unit were found complying, **05** nos of stone crushing units have been dismantled and **06** nos of stone crushing units were found non complying due to inadequate air pollution control measures in the premises as per notification dated 11.05.2016.


Suggestion of remedial measures:

1. Closure action along with levy of Environment compensation on thenon-complying stone crushing units of Birhi Kalan, Charkhi Dadri be initiated by HSPCB.
(Action by: HSPCB)
2. The forest Department should carry out strip plantation on the route towards stone crushers of Birhi Kalan, Charkhi Dadri, with assistance of stone crushing units as required by the Forest Department.
(Action by: Forest Department)
3. Regular monitoring of stone crushing units of Birhi Kalan, Charkhi Dadri be carried out.
(Action by: HSPCB)
