ORDER

1. Grievance in this application is against failure of the Coimbatore Municipal Corporation and District Magistrate, Coimbatore to implement order of this Tribunal dated 03.10.2018 in *O.A. Nos. 523/2018 and O.A. No. 524/2018, Shri V. Eswaran, Coimbatore v. The District Collector, Coimbatore & Ors.* and *Shri K.S. Mohan v. UOI & Ors.*

2. By the said order, the Tribunal directed time bound action for remediation of solid waste and filing of report in *O.A. No. 606/2018, Compliance of Municipal Solid Waste Management Rules, 2016 and other environmental issues.*

3. According to the execution application dated 18.08.2022, the dump site has still not been remediated and fresh waste is being dumped. On

account of unscientific management of the dump site, a woman died while collecting plastic waste on 08.04.2022.

4. In view of above, District Magistrate Coimbatore and Commissioner, Municipal Corporation, Coimbatore may look into the matter and take remedial action in accordance with law. An action taken report with factual status of legacy waste dump site and remedial action by way of waste processing plant and relating to incident of death may be filed by e-mail at judicial-ngt@gov.in preferably in the form of searchable PDF/ OCR Support PDF and not in the form of Image PDF within two months.
