

May it please your honour

The answering respondents respectfully submit as under:-

1. That the applicant filed instant application before the Hon'ble National Green Tribunal praying therein to prevent illegal mining, discharge of sewage and dumping of solid waste into river Doodh Ganga and Mamath Kull, which is in violation of provisions of the water (Prevention and Control of Pollution) Act-1974, judgments of the Hon'ble Supreme Court

dated 22-02-2017 inter alia in Paryavaran Surkasha Samiti Vs Union of India orders of this Tribunal on the subject.

2. That Doodh Ganga river originates from Pir Panjal Mountains having the length of 42.7 Kms, the Mamath Kull is a small stream also originating from Pir Panjal and the jurisdiction of these two rivers fall within the limits of Rural Development Department, Urban Local Bodies and Srinagar Municipal Corporation.
3. The Hon'ble National Green Tribunal constituted the Joint Committee in order to look into the water quality in terms of fecal coli form, quantity of sewage discharged, solid waste being dumped on the banks. The Committee has recommended various measures to be taken by the executing agencies in time bound manner in its report submitted pursuant to the direction of the Hon'ble National Green Tribunal.
4. That the Housing and Urban Development has filed the detailed report on 14.01.2022 with respect to the Sewage Management, Solid Waste Management, awareness activities and regulation of mining activities alongside the river Doodh Ganga and Mamath Kull.

5. That the Hon'ble Nation Green Tribunal, Principal Bench, New Delhi, while hearing the application on 08-03-2022, has observed as under:-

"13....., we direct the Chief Secretary, J&K to take immediate remedial action to remedy the situation by ensuring clean environment and also taking coercive measures against the erring irresponsible officers, acting in contempt of directions of the Hon'ble Supreme Court and this Tribunal and causing detriment to the environment and public health. We need not comment upon the measures suggested in the report as the Tribunal is concerned with enforcement of obligation of the State to provide clean environment. It is for the State Authorities to decide as to which measures are appropriate so as to prevent pollution of the river and prevent other violations of environmental norms and what is the source of funding.

14. We find that neither the dumping of solid waste nor discharge of untreated sewage has been prevented nor illegal mining stopped and nor legacy waste cleared for which statutory timelines have already expired. The State is accordingly held liable to pay interim compensation of Rs. One crore each under all the three heads which may be deposited in a separate account to be utilized for restoration of environment. The amount may be deposited with the District

Magistrate, Budgam and spent as per plan approved by the Chief Secretary, consistent with the District Action Plan of the concerned area
15. An action taken report may be filed before the Tribunal by the Chief Secretary personally, after interaction with the concerned officers within three months. The report may specify status of facilities to treat sewage as well as fecal sludges, protection of flood plain, lifting of waste from the banks of Doodh ganga and Mamath Kull to the identified sites and processing it as per MSW rules, cow dung management and other associated issues”.

6. That pursuant to the directions of the Hon'ble National Green Tribunal, The Chief Secretary, UT of J&K took various meetings on the subject dated 18.04.2022 and dated 07.06.2022. Besides the Principal Secretary to Government, Housing & Urban Development Department has convened a series of meetings /personal interactions with concerned Officers on 15-03-2022, 17-05-2022 and 27-05-2022 and accordingly remedial measures required with respect to Sewage Management, Solid waste Management, Legacy Waste Management alongside the bank of Doodh Ganga Nallah and Mamath kull have been taken on war footing. The minutes of the meeting are enclosed herewith as Annexure as R1, R2 and R3.

7. That Hon'ble National Green Tribunal has held UT of J&K liable to pay an interim compensation of Rs. 1 crore each under three Heads namely, Solid Waste management, Sewerage Management and Mining. The Srinagar Municipal Corporation has deposited the interim compensation of Rs 1.00 Crore and Municipal Committee Chadoora and Budgam have also deposited interim compensation of Rs 50.00 lacs each with the office of DC, Budgam on account of Sewerage & Solid Waste Management. The deposition of interim compensation of Rs 1.00 crore on account regulation of mining activities is under process and will be deposited shortly. Instructions in this regard have been issued.
8. That the action taken report received with respect to the Sewage Management, Solid Waste Management and Mining regulations alongside the bank of Doodh Ganga Nallah and Mamath Kull is as under:
 - i). That the total sewerage generated from 07 wards of Srinagar Municipal Corporation forming the catchment of 13 dewatering stations (10 main & 03 secondary) on the two sides of Doodh Ganga Nallah is estimated as 16.23 MLD, whereas the untreated sewage falling into the Doodh Ganga Nallah through these Dewatering stations is 12.25 MLD. The balance sewage of 4.11 MLD gets treated in the septic tanks/soakage pits.
 - ii). That the sewerage treatment of Doodh Ganga Nallah from Bemina to Baghi- Mehtab, Srinagar was already been reflected in the DPR submitted to the JICA for an amount of Rs. 964.48 Corers. However, due to delay in the sanctioning of the project by JICA and in view of the directions of Hon'ble National Green Tribunal, a fresh DPR for

Doodh Ganga from Bemina to Bagh-i-Mehtab has been prepared by the Srinagar Municipal Corporation in consultation with Chief Engineer UEED to the tune of Rs. 59.13 Crore covering a population of 2.66 Lac by 2052 with the capacity of 12.24 MLD. The DPR proposes to construct Sewerage Treatment Plants for treatment of untreated Sewage coming out from these dewatering stations for the following areas within the jurisdiction of SMC tabulated below:-

- iii). The total sewerage generation on Doodh Ganga beyond Baghi Mehtab under the jurisdiction of urban local bodies, Kashmir is 4.30 MLD and all this untreated sewage is now proposed to be treated by way of Sewage Treatment Plants. The Project Feasibility Report for sewerage treatment beyond Bagh-e-Mehtab has also been framed for an amount of Rs. 89.34 crores covering a population of 0.53 lacs by 2037 with the design discharge of 4.3 MLD capacity with proposed STP at Kralpora including intermediate pumping stations, through the existing consultant by increasing the scope of his contract for areas

within the jurisdiction of Urban Local Bodies, Kashmir i.e, Chadoora Town, Kral Pora, Moochu, Soigam, Hanji Gund, Batpora, Sheikh Pora, Chana Mohalla. The said PFR have been submitted for technical vetting to IIT, Roorkee. The areas proposed to be covered with treatment of Sewerage and DWF Discharging into Doodh Ganga Nallah from Baghi Mehtab to Chadoora is tabulated below:-

- iv). The recommendations made by the Committee before the National Green Tribunal with regard to Sewerage Management are being addressed with the establishment of STPs, laying of sewerage network and connections and treatment of waste water. A copy of the letter dated 31/05/2022 received from Chief Engineer, UEED is enclosed as **Annexure R-4.**
- v). That the Srinagar Municipal Corporation and Urban Local Bodies are responsible for management of Solid Waste alongside the bank of river Doodh Ganga and Mamath Kull within their jurisdictions.
- vi). That in order to redress the issue of handling/ managing and disposal of waste generated in all the 78 Urban Local Bodies, of UT of J&K, the State Level Apex Committee in its meeting held on 16-03-2021 and 30-07-2021 under the chairmanship of Chief Secretary of J&K UT approved the Capex under decentralised Solid Waste Management Action Plan for an amount of Rs. 648.00 Cr .
- vii). That the overall cost of the project for (40) ULBs of Kashmir Division for establishment of decentralized facilities is **Rs. 191.67 Crores.** The Budgam and Chadoora towns being the important towns of Central Kashmir and to ensure the restoration and preservation of the prestigious water bodies of Doodh Ganga and Mamath Kull, comprehensive Solid Waste Management facilities have been approved for Budgam town at the cost of **Rs. 299.47 Lakhs** at Pallar Budgam with two Waste Management Centers of 5 TPD capacity and for Chadoora town at Hayatpora at the cost of **Rs 124.38 Lakhs** consisting of 01 Waste Management Center of 4 TPD capacity. The

work on the project has been started by way of construction of Waste Management Centre at the site.

viii). That the Waste generation details of two towns viz. Municipal Council Budgam & Municipal Committee Chadoora as given hereunder:

ix). That the Urban Local Bodies, Kashmir has already initiated the process for procurement of collection and transportation infrastructure through State Motor Garages J&K and in the first phase (107) sanitation vehicles (Hoppers) have been procured, out of which 04 Hoopers are provided to Municipal Council Budgam and MC Chadoora is already having the requisite vehicles in place for door to door collection/segregation of waste.

x). That for proper and effective implementation Solid Waste Management Action plan, a dedicated Project Management Unit has already been engaged by the Department for effective implementation of Solid Waste Management. The PMU is operating from the Directorate and

have visited the sites identified for establishment of SWM facilities in Budgam and Chadoora towns;

- xi). That to prevent the open littering of waste by the households, MC Budgam has distributed about 1700 Dustbins in the town and MC Chadoora has also distributed about 1500 Dustbins during the current financial year at different intervals.
- xii). That Doodh Ganga also known as Chatche Kull passes through the Chadoora Town and around two (02) Kilometers of stretch of Doodh Ganga traverses the town. The main source of pollution of Nallah Doodh Ganga has been observed as waste from residential houses located near the banks of Nallah, and effluents from restaurants Hotels and Work Shops, dumping of refuse by the local inhabitants, for which the Municipal Committee Chadoora has taken action and the waste scattered on the banks of Nallah Doodh Ganga has been removed. About 90 MTs of legacy Waste has been removed from the banks of Doodh. Ganga using men and machinery of Municipal Committee Chadoora falling within the jurisdiction of MC Chadoora and at present there is no waste lying on the banks of Doodh Ganga within jurisdiction of MC Chadoora.
- xiii). That Banners/digital sign boards at various locations including banks of Nallah Doodh Ganga have been installed for awareness of general public, also announcements were made on public address system regarding cleanness of Doodh Ganga, Masjid Committees/ Auqaf Committee of town Chadoora were also requested to make general public aware about the importance of cleanness of water body.

Special teams have been constituted by MC Chadoora to keep strict vigil on the encroachments of banks of Nallah and littering of waste by the inhabitants. Municipal Committee Chadoora has conducted plantation drives in collaboration with Social Forestry Department on the banks of the Nallah to avoid its erosion. The issue regarding construction of Sewage treatment plants of adequate capacity had been taken up with the UEED Department. During last few days, the Vigilance teams of MC Chadoora have imposed fine on (08) violators of Rs. 4500/- and three No. of FIRs have also been filed against the violators to serve a deterrent to the violators. Around 116 ton of garbage have been lifted during the year 2021-22, 2022-23.

- xiv). That the Mamath Kull passes through the Budgam town and the main source of pollution has been identified as littering of waste by people living in the vicinity of the water body into the Kull and on its banks, for which the MC Budgam has taken strict measures to have a total prohibition of illegal dumping and disposal of Solid Waste along the banks of Mammat Kull. A special team has been constituted to ensure strict prohibition of dumping of garbage/Solid Waste/ Single Use Plastic within 500 metres of the banks of the Kull, besides, imposition of fine upon the violators as per the provisions of SWM Rule, 2016. The constituted teams have been patrolling in the area frequently and during last few days 8 violators have been imposed fines and FIRs have also been filed against the violators to disseminate a strict message among the public. The cleaning of Mamath Kull has been undertaken by Municipal Council Budgam. The Digital Displays have been installed/ erected at different places from New Adda to Old Adda in

order to create awareness in general public. 100% percent door to door collection has been achieved in all the wards of the Town.

- xv). That the Srinagar Municipal Corporation is practicing 100% door to door waste collection throughout the city including from the households putting up on both sides of Doodh Ganga canal from Bagh-i-Mehtab to Hokarsar. All the waste deposited on the banks of the Doodh Ganga has been removed and cleared and there is no solid waste accumulated anywhere in the Nallah in the SMC jurisdiction. One major waste collection point was setup near the Baghi-Mehtab area. The said waste collection point has been closed down and a public park has been decided to be constructed there. Strict action is being taken against the offenders who are being found littering the Doodh Ganga Canal. An amount of Rs. 181,000/- has been recovered from 55 offenders who were found littering the Doodh Ganga from 19/12/2021 to 19/5/2022. A detailed list is enclosed herewith as **Annexure-R-5**.
- xvi). That the photographs of some activities undertaken by Srinagar Municipal Corporation, Municipal Committee Chadoora and Municipal Council Budgam are enclosed as **Annexure R-6**.
- xvii). That the Director Soil and Water Conservation, Forest, Ecology & Environment Department has submitted a proposal for development of green belts and soil erosion control measures on the embankments of river Doodh Ganga/Mamath Kull covering a total length of 42 Kms. over a period of 5 years for an amount of Rs. 30.85 Crore. However, during the current year, the preliminary working plan for first phase has been prepared by the Director, Soil &

Water Conservation, Forest Ecology and Environment Department for an amount of Rs. 5.82 Crore for beautification of embankments from Doodh Ganga Nallah from Branwar up to Railway Bridge, Bagh-i-Mehtab and further extended up to Bemina against which a provision of Rs. 2.00 Crore has already been kept in the Capex Budget. The site specific micro plans for the works proposed are being prepared by ground truthing and shall be finalized in collaboration with irrigation and flood control department. The details showing abstract costs of each work and District wise activities against this annual plan are given in Annexure "R-7 & R-8".

- xviii). That Prior to 2016, the extraction of river bed material from Doodh Ganga was allowed and governed by J&K Minor Mineral Concession Rules, 1962 where under the provision of Short Tem Permit on advance payment of royalty was allotted for a specific period of time. With the notification of "The J&K Minor Mineral Concession, Storage, Transportation of Minerals and Prevention of Illegal Mining Rules, 2016" vide SRO-105 dated; 31st of March 2016," the Department of Geology & Mining identified 03 number of the minor mineral blocks in Doodh Ganga Nallah in an environmentally viable areas for e-auction viz-a-viz mineral concession for regulating and sustainable mining in the area.
- xix). Out of 03 identified mineral blocks, 02 blocks were successfully e-auctioned through the District Auction Committee headed by Concerned Deputy Commissioner. The blocks stand leased out to the successful bidders after completion of all the statutory clearances like submission of approved Mining Plan, valid Environmental Clearances,


Consent to Operate, from the competent authorities besides clearances/NoCs from all the stake holding Departments. The mineral blocks are operational and are working as per terms and conditions of approved mining plan, EC, CTO and Sustainable Sand Mining Guidelines 2016/2020. Checkpoints have been established at the exit points of both the operational blocks to monitor and regulate the extraction and transportation of mineral from the leased blocks.

- xx). Extraction of river bed material from the Mamath Kul has been completely stopped after the only exit point near Mamath Bridge stands closed. Lastly the Dy. Commissioner, Budgam Vide Order No. 179 DCB of 2021 dated: 13.07.2021 constituted multi departmental teams at Sub-Divisional and Tehsil Level to curb the illegitimate extraction of minerals in the District.
- xxi). That On the directions of the Dy. Commissioner, Budgam a joint inspection of e-auctioned minor mineral blocks, Doodh Ganga nalla was carried out on 17.03.2022 by the Department of I&FC, Geology & Mining, PHE and Fisheries wherein the committee reported that the extraction of the minerals in the leased out blocks has been executed systematically & scientifically as per the prescribed guidelines. Copy of the report and photographs captured on spot are enclosed as **Annexure R-9**.
- xxii). The Department takes due cognizance of any reported illegal mining activity in the area under reference and stringent actions are ensured against the offenders which include lodging of FIRs, dismantling of approach roads, seizing of tools/equipments/ vehicles/JCBs and

compounding under rules. From April 2020 to August 2021, the District Mineral Office, Budgam seized 36 vehicles involved in illegal extraction/transportation of minerals with a collection of Rs 4,53,338 as compounding/penalty from the offenders. Presently no illegal mining takes places in the Doodh Ganga Nallah.

- xxiii). That the Mining Department has given an undertaking that at present no illegal mining is taking place. The copy of which is annexed as **Annexure R-10.**

Minutes of the meeting held under the Chairmanship of Principal Secretary to Government, Housing & Urban Development Department on 15.03.2022 at Civil Secretariat, Jammu.

A Meeting was held on 15.03.2022 at 4.00 PM under the Chairmanship of Principal Secretary to Government, Housing & Urban Development Department to discuss the way forward on the actions required to be taken in compliance to Order dated 08.03.2022 pass in O.A. No. 241/2021, titled Raja Muzzaffar Bhat Vs Union of India.

The following officers were present in the meeting:-

1. Commissioner/Secretary to Government, Forest, Ecology & Environment Department.
2. Commissioner, Srinagar Municipal Corporation.
3. Director, Soil Conservation, J&K.
4. Director, Geology & Mining, J&K.
5. Director, Urban Local Bodies, Kashmir (through VC).
6. Chief Engineer, UEED, J&K (Through VC).
7. Chief Engineer, Irrigation & Flood Control, Kashmir.
8. Special Secretary, (legal) Housing & Urban Development Department.
9. Director Planning, H&UDD.
10. Additional Secretary(R) to Government, H&UDD.

At the Outset, Principal Secretary to the Government, Housing & Urban Development Department briefly outlined the action that needs to be taken by the concerned Departments/Agencies in view of the directions issued by Hon'ble Tribunal vide its orders dated 08.03.2022 in the aforementioned case.

After threadbare discussion on the actionable points, the following directions were imparted by the Chair to the officers/Departments concerned for ensuring that the directions passed by Hon'ble NGT in the case are complied with:-

A. Sewage Management:

1. The Chief Engineer, UEED and Commissioner, SMC were directed to prepare the Detailed Project Report (DPRs) for establishment of modular STPs for treatment of untreated waste coming out from dewatering stations which were directly flowing in river Doodh Ganga &

Maamath Kull. The DPRs shall be submitted to the Department by or before 15.04.2022, so that the matter can be placed before Worthy Chief Secretary for accord of Administrative approval in a time bound manner.

B. Solid Waste Management:

1. The Commissioner Srinagar Municipal Corporation was directed to take concrete action to clean up solid waste dumped on the banks of river Doodh Ganga & Mamath Kull falling under his jurisdiction and also remove all dumpsites alongside banks of these rivers. A detailed report in this regard shall be submitted to Administrative Department on weekly basis along with photographs showing the now and then status of removal of solid wastes.
2. Director Urban Local Bodies, Kashmir was directed to remove all dumpsites alongside banks of these rivers. A report in this regard shall be submitted to Administrative Department on weekly basis showing the now and then status of removal of solid wastes. The Director Urban Local Bodies, Kashmir was directed to adhere to the provisions of the Solid Waste Management Rules, 2016 at dumpsites in and around the Doodh Ganga nalla and Mamath Kull. She was further directed to ensure that the dumping of Solid Wastes on existing dumpsite is stopped on Mamath Kull and change dumping site to newly identified land fill site. She was directed that the work on the approach road to the newly identified dumping sites shall be completed at the earliest and compliance report submitted to the Department by or before 31.03.2022.
3. The Deputy Commissioner, Srinagar and Deputy Commissioner, Budgam were directed to review the cleaning up of solid waste dumped on the banks of river Doodh Ganga & Mamath Kull falling under their respective jurisdiction (both urban and Rural areas) and report to the Department and Rural Development Department regarding violations noticed.
4. The Deputy Commissioner, Budgam was directed to identify a land for landfill sites at MC, Khansahib so that compliance report is filed as per the directions given by the Hon'ble Tribunal. The Deputy Commissioner, Budgam was directed to work out the extent of solid waste deposited in the Urban as well as Rural areas so that expenditure on this count is shared by both Urban and Rural Development Department.

C. Awareness Activities:

1. The Deputy Commissioner, Budgam and Deputy Commissioner, Srinagar, Commissioner SMC and Director Urban Local Bodies, Kashmir, Member PCB were directed to promote and create environmental awareness activities through add on media and also by sustained awareness/sensitization programmes in the problematic areas to prevent dumping of wastes in water bodies/ Drains and its adverse effect on human health and environment.

D. Regulation of Mining Activities:

1. The Director, Geology & Mining was directed to take immediate action to prevent illegal mining and prevent damage to the environment/river as per the directions of Hon'ble Tribunal.
2. The Director, Soil Conservation was also directed to develop green belts & green ways on both sides of the embankments of river Doodh Ganga & Mamath Kull, for controlling erosion, reducing sediment load of the main channel, reducing pollution and enhancing beautification and submit a report in this regard on weekly basis.

Minutes of the meeting held under the chairmanship of the Principal Secretary on 17th May, 2022 to review the implementation of directions of Hon'ble NGT regarding the SWM rules 2016, Action Plan for elimination of single use plastic, 9 river stretches and issues pertaining to River Doodhganga in light of the judgment on 30.11.2021 on OA. No. 606/2018 SWM and OA. No. 673/2018.

The following officers/officials participated:-

1. Director Soil and Water Conservation Department, Forest Department, J&K.
2. Chief Executive Officer, Compensatory Afforestation Fund Management & Planning Authority (CAMPA), Forest department.
3. Director Urban Local Bodies Kashmir.
4. Director Urban Local Bodies Jammu.
5. Chief Engineer, J&K UEED.
6. Special Secretary, Legal H&UDD.
7. Representatives of Commissioner, SMC/JMC.

At the outset, the Principal Secretary to Government, Housing and Urban Development Department pointed out that implementing agencies should ensure submission of updated action taken report on OA. 606/2018, SWM and 673/2018 as per the prescribed time schedule. The Principal Secretary, HUDD also pointed out that Hon'ble NGT has held State liable to pay an interim compensation of an amount of Rs. 1.00 Crore for each under 03 Heads namely solid waste management, sewage management and mining. Mining will be dealt by Mining Deptt; however, for SWM & Sewage management the compensation of Rs. 2.00 Crore has to be borne by HUDD and deposited in the office of Deputy Commissioner, Budgam.

The proposal of Forest Department for afforestation of Doodhganga for an amount of Rs. 30.85 Crore over a period of 5 years for development of green belts and soil erosion control measures on the embankment of river Doodhganga

covering a total length of 42 Kms. was discussed in detail. It was informed by Chief Executive Officer, CAMPA that there is no provision under CAMPA for funding the said project, besides, the guidelines of CAMPA does not permit the utilization funds for the said project and request was made to the chair for funding of the project for over a period of 5 years. It was informed by Director Soil & Water Conservation, Forest Deptt. that Rs. 5.82 crore will be required for beautification of embankments of Doodhganga for the Current Financial Year 2022-23.

The SE, Drainage SMC informed the chair that a PFR for an amount of Rs. 59.13 Crore have been formulated for preventing Daily Dry Weather Flow (DDWF) discharging into the Doodhganga Nallah and has requested to fund the project. It was pointed out by him that the jurisdiction of SMC for treatment of Doodhganga Nallah is upto Baghi-Mehtab and beyond that it should be looked after by Director Urban Local Bodies Kashmir and Chief Engineer, J&K UEED.

Director, Urban Local Bodies Kashmir informed that various IEC activities viz. cleanliness and awareness drives were conducted, besides, boards have been installed to prevent people throwing garbage into the water bodies.

Special Secretary (Technical) Forest, Environment & Ecology Deptt. informed the chair that she has shared the Action Taken Report on OA. 606/2018 SWM with the Implementing Agencies of the H&UDD and sought their cooperation for updating of the same within a week's time. It was further pointed out by her that the portal for elimination single use plastic needs to be updated regularly on monthly basis and requested to nominate one Nodal officer for the same.

After threadbare discussions the following decisions were taken:-

1. The H&UDD will fund the project for development of green belts and soil erosion control measures on the embankment of river Doodhganga covering a total length of 42 Kms over a period of 5 years for an amount of Rs. 30.85 crore. However, Director, Soil and Water Conservation Department, Forest Department, J&K shall submit the DPRs dully vetted for an amount of Rs. 5.82 Crore alongwith Accord of Administrative Approval to H&UDD for funding during the initial year of 2022-23 as per the proposal submitted by the Forest, Ecology & Environment Deptt.

2. The PFR submitted by Commr., SMC for an amount of Rs. 59.13 crore for preventing Daily Dry Weather Flow (DDWF) discharging into the Doodhganga Nallah was approved for funding under capex budget of SMC for the year 2022-23. However, SE, Drainage Circle, SMC was directed to get it technically vetted from the competent authority and submit the same to the Administrative Deptt. for further necessary action.
 3. MD, SBM(U)-2.0 shall be nominated as Nodal officer for implementation of SWM rules 2016 and elimination of single use plastic. The officer shall ensure that all the requisite information is obtained from all the ULBs with regard to Solid Waste Management and Single Use Plastic and consolidate the said information prior to its submission to the Special Secretary (Technical) FE&E Deptt. for further uploading the same on portal.
 4. Director, Urban Local bodies Kashmir shall ensure the submission of IEC activities viz. videos of cleanliness drives and awareness activities on weekly basis to the Administrative Deptt., besides, necessary penalties should be imposed on the violators so as to prevent people throwing garbage into the Doodhganga Nallah.
 5. The Implementing Agencies shall furnish the updated Action Taken Report on OA. 506/2018 and OA. 673/2018 to the Administrative Department with a copy endorsed to the Forest Deptt.
 6. The Chief Executive Officer, Shri Mata Vaishno Devi Shrine Board shall be asked to submit the latest Action taken Report on Banganaga. Special secretary, Law shall obtain the same and put up for perusal of the chair and subsequently fix a meeting on the subject on 24.05.2022.

At the outset, the Special Secretary, Legal (HUDD) informed the chair that Hon'ble NGT has held State liable to pay an interim compensation of an amount of Rs. 1.00 Crore for each under 03 Heads namely solid waste management, sewage management and mining. Mining will be dealt by Mining Deptt; however, for SWM & Sewage management the compensation of Rs. 2.00 Crore has to be borne by SMC and DULBK @ Rs. 1.00 Crore each and deposited in the office of Deputy Commissioner, Budgam.

The Principal Secretary pointed out that the interim compensation as directed by Hon'ble NGT have to be deposited in the Office of Deputy Commissioner, Budgam by all the concerned stakeholders including the Department of Mining in order to comply with it Order dated: 08.03.2022. The Director, Geology & Mining informed the chair that the Deptt. does not have sufficient resources to meet the interim compensation and the matter has accordingly being taken up with the higher authorities for the release of funds on this account and the decision is likely to be taken shortly.

Commissioner, SMC and DULBK agreed to deposit the interim of compensation of Rs. 1.00 crore each from their own resources in the Office of Deputy Commissioner, Budgam within three days.

Deputy Commissioner, Budgam informed the Chair that the account has been opened by his office for depositing the interim compensation of Rs. 3.00 Crore as per

the directions conveyed by Hon'ble NGT, however the same is yet to be deposited by the concerned agencies.

After threadbare discussion the following decisions were taken in the meeting.

1. Commissioner Srinagar Municipal Corporation and Director Urban Local Bodies will deposit an amount of Rs.1.00 Crore each under the two heads, namely solid waste management and sewerage management out of their own resources by or before 30th of May-2022 positively.
2. Director Geology and Mining will ensure that the interim compensation of Rs. 1.00 Crore (Regulation of Mining) is deposited by him in the Office Deputy Commissioner, Budgam by 30th of May, 2022 so as to comply the direction passed by the Hon'ble National Green Tribunal in its order dated.08.03.2022. and also furnish up-to-date status within three days positively.
3. Commissioner Srinagar Municipal Corporation and Director Urban Local Bodies Kashmir will provide updated status on solid waste management by or before 30th of May-2022 positively.
4. Commissioner Srinagar Municipal Corporation has agreed to get the DPR for the sewerage treatment beyond Baghi-Mehtab upto Chadoora framed through the existing consultant by increasing the scope of his contract. However, Chief Engineer, UEED will provide all necessary technical support in this regard.
5. Director Soil Conservation shall furnish the Detailed Project report alongwith AAA and Technical vetting for an amount of Rs. 5.82 crore to be taken up for Phase-I during the CFY for development of green belts and soil erosion control measures on the embankment of river Doodhganga covering a total length of 42 Kms. within three days.
6. The Special Secretary, Legal (HUDD) will obtain the Action taken Report from Commissioner, SMC, DULBK, Director Geology & Mining and put up accordingly for information/perusal of the Chief Secretary.





During inspection, the following observations were made:


- The minerals are being excavated from the blocks well within the area allotted to the lessees.

- Mining operations in both the blocks are in accordance with the applicable provisions of Mines Act, 1952, Mines and Minerals (Development and Regulation) Act, 1957, Sustainable Sand Mining Management Guidelines 2016, Jammu and Kashmir Water Resources (Regulation and Management) Act, 2010, and Environment (Protection) Act, 1986, Water (Prevention and Control) Act, 1974 and air (Prevention and Control of Pollution) Act, 1981.
- Scheme of Mining is strictly as per the approved Mining Plan and the conditions of Environmental Clearance and Consent to Operate.



Now therefore, in exercise of powers conferred under section 427 of the Jammu and Kashmir Municipal Corporation Act, 2000, the Government hereby makes the following order, namely:-

1. Short title and commencement:- (1) This Order may be called the Jammu and Kashmir Municipal Corporation (Removal of Difficulties) Order, 2022.

(2) It shall deemed to have come into force w.e.f 01.01.2021 and shall remain in force for a period of two years or till it is revoked by the Government, whichever is earlier.

2. Removal of Difficulties:- The difficulties arising in giving effect to the provisions of section 45 of the Jammu and Kashmir Municipal Corporation Act, 2000 have been removed in the following manner, namely:-

In section 45, after sub-section (1), following proviso shall be inserted namely:-

"Provided that notwithstanding anything contained in subsection (1), the Government may appoint any suitable officer as Commissioner of the Corporation, irrespective of his service experience, for the smooth functioning of the Corporation."
