Further, the DPCC has nominated Sh. Ashish, Junior Environmental Engineer (Mobile No. 8003044880) as member from DPCC for the aforesaid Joint Committee. (Copy of letter is enclosed herewith).
- 4. That accordingly, a meeting notice cum survey was issued vide letter no. F.SDM/KOT/DPCC/2023/7823-27 dated 31.03.2023 by this office with the request to the concerned agency / department attend the meeting on 03,04.2023 on 10:30 A.M. in the office of SDM (Kotwali). (Copy of meeting notice cum survey is enclosed herewith).

- 5. That the meeting was headed under the chairmanship of SDM (Kotwali) on dated 03.04.2023 and all the concerned agency / department was directed to inspect the above said alleged site.
- 6. That as decided in the meeting, the joint inspection was carried out at the site by the Tehsildar (Kotwali) along with Sh. Sohan Lal, LDC (CSPZ), MCD & Sh. Ashish, JEE, CMC-VII, DPCC on 03.04.2023. The detailed report is as under:-

Joint inspection of alleged sites B-1757/9/10 and B-1757/10, Lankapuri, Hanuman Gate, Shastri Nagar, Delhi-110052 5. The conducted by officials of MCD, DPCC and District Magistrate (Central) on 03.04.2023 in presence of complainant Sh. Jagdeep Kumar.

During joint inspection, following observations were made:

- (i) Both the alleged sites are situated in residential area at Lankapuri, Hanuman Gali, Shastri Nagar, Delhi-110052.
 - (ii) At the ground floor of alleged site at B-1757/9/10, Lankapuri, Hanuman Gali, Shastri Nagar, Delhi-110052, an illegal unit found operational & engaged in stitching & tailoring of hosiery cloths with 10 stitching machines and another illegal unit found operational & engaged in the manufacturing of cartons from paper cardboards with 4 cutting & stapling machines. However, all the floors except the ground floor of this site are occupied by residents.
 - (iii) At the ground floor of alleged site at B-1757/10, Lankapuri, Hanuman Gali, Shastri Nagar, Delhi-110052, an illegal unit found operational & engaged in the cutting & turning of metallic parts with 4 lathe (ii) machines. However, all the floors except the ground floor of this site are occupied by residents.
 - (iv) All the 3 units mentioned above are operating illegally without having any license from the Government departments.

The notices have been duly served upon to the owner / occupiers of the above said property on dated 25.04.2023 & 26.04.2023. (The copy of notices is enclosed herewith).
