O R D E R

By an Order dated 29.04.2019, we requested the Central Water and Power Research Station (CWPRS), Pune to expedite the enquiry pertaining to the mitigation of the flood problem in the Ghaggar basin and submit a report by the first week of July, 2019. We are informed that the enquiry has not been completed since the States of Haryana and Punjab did not furnish requisite information.
