As per directions issued from Hon'ble National Green Tribunal Principal Bench, New Delhi, the point wise reply from Haryana Irrigation & Water Resources Department is as under for the kind consideration of Hon'ble NGT.

(1) <u>Disposal of C&D waste from Ghaggar plain:</u>

The C&D waste from the Ghaggar plain has been lifted and disposed off with the help of District Administration, HSVP and Municipal Corporation of Panchkula. The pictures of lifting the C&D material from the flood plains has been attached as **Annexure-1**. It is also worthwhile to mention here that lots of construction activities is going on in the vicinity of Ghaggar plain around Sector-25 and Sector-26, Panchkula. The Municipal Commissioner has been intimated to stop the further dumping of C&D material in future on the banks of river Ghaggar by installing CCTV Cameras, issue of notices/ challans and deployment of manpower of watch & ward. The letter written to Commissioner, Municipal Corporation, Panchkula dated 25.01.2023 is attached as **Annexure-2**.

(2) <u>Demarcation and Notification of flood plain zone:</u>

In this regard, Haryana Irrigation & Water Resources Department with the help of Halka Patwaries has surveyed the whole area of the flood plain zone of Ghaggar river in District Panchkula. Requisite Sajra plan has been obtained from Revenue Department and the work of demarcation of flood plain zone is under process in Water Services Sub Division, Panchkula. The process of demarcation on Sajra plan will be done within seven days and the file for the notification of the flood plain zone under Canal & Drainage Act, 1974 will be sent to Govt. subsequently.

It is humbly requested to consider the point wise reply from the Commissioner and Secretary to Govt. of Haryana, Irrigation & Water Resources Department In Compliance Of Orders. Dated 11.01.2023 further received from Sr. Additional Advocate General, Haryana dated 21.01.2023.
