# STATUS REPORT ON BEHALF OF DELHI POLLUTON CONTROL COMMITTEE WITH RESPECT TO ORDER DATED 04.04.2024.

- That this Hon'ble Tribunal took up the above referred matter on 20.04.2023, regarding restaurants, bars, pubs and cafes which have been running Live Music Events on open Rooftops, using loudspeakers and other sound equipment's at Hauz Khas Village, in violation of the Noise Pollution (Regulation and Control) Rules, 2000.
- 2. That, in compliance with the previous orders' of this Hon'ble Tribunal in the above-mentioned matter, DPCC filed the reports on 25.08.2023, 07.12.2023 and 02.04.2024 which are available on the records of this Hon'ble Tribunal.
- 3. That, this Hon'ble Tribunal has considered the report on 04.04.2024 and pleased to direct DPCC to file list of all eateries/restaurants etc. established/operating in the area with complete particulars and compliance status so that all the violators can be impleaded as parties to the present

application and appropriate orders can be passed by this Tribunal after granting opportunity of being heard to them.

- 4. That, SDM has issued challans of Rs. 10,000/- each to 10 units for violation of the Noise Rules, 2000. SDM (Hauz Khas) has sent the payment receipts of 10 units as on 13.04.2024. After the verification of 10 payment receipts, it was found that the EC amount has been received only from 7 units out of 10 and transaction number of payment receipts of 3 units are not matching. Copy of the list of said 10 units is attached herewith as **ANNEXURE-1**.
- 5. That, vide joint inspection by SDM (Hauz Khas), MCD and DPCC 23 units were inspected earlier. Out of the said 23 units, 4 units were found to be non-compliant and action has been taken. Status report was filed before this Hon'ble Tribunal. However, as per online record of DPCC, apart from the above 23 units, 8 more units have taken consent from DPCC. Copy of the list of total 31 units (inclusive of 23 units to whom details were filed in the ATR dated 07.12.2023) is attached herewith as **ANNEXURE-2**.
- 6. That, SDM has informed that 3 units, against whom closure directions were issued by the DPCC u/s 33(A) of Water Act, 1974 and 31(A) of Air Act, 1981, have been sealed on 06 April 2024. These 3 units were found to be operating without requisite pollution control systems and without CTO by the Joint Committee during earlier inspections. Compliance report from BSES Rajdhani Power Ltd and DJB is awaited in response to the closure directions of DPCC issued on 01.04.2023. These four units were also required to deposit the EDC within 15 days, which has not yet been received so far.
- 7. In view of the above, the present action taken report may kindly be taken on record.
