**Report of the Joint Committee in the matter of pond bearing
Khasra no. 111 (13-10) in village Kanganheri, Delhi**

Whereas, in compliance of order dated 13.12.2023 & 13.03.2024 of the Hon'ble Tribunal, a joint committee of stakeholder agencies was constituted with the directions for demarcation of land of pond having khasra no. 111 (13-10) situated in area of village Kanganheri and submit report of encroachment, if any, with all details regarding area of encroachment and construction if any thereon, with particulars of the person alleged to have made the encroachments.

It is respectfully and humbly submitted that the demarcation of Khasra No. 111 (Gram Sabha Johad) was conducted on 27.03.2024 by the revenue field staff through TSM method on the directions of the Hon'ble NGT, New Delhi after considering the chakbandi/ reference stones. Copy of the same is annexed as A-I.

After conducting demarcation through TSM method, it has been noticed that there are some amount of illegal encroachments/ illegal possessions on the Khasra No. 111 (GS Johad) situated in the revenue estate of village Kanganheri, New Delhi. Which have been shown in the map prepared by the surveying agency M/s Bhardwaj Survey Design, New Delhi-68 hired by the Revenue Department. Copy of the same is annexed as A-2

After that on the basis of the map submitted by the surveying agency , the earmarking with nail/paints was done on the ground. Copy of the same is annexed as A-3.

Further, surveyor while carrying out the demarcation has taken three reference points from where the demarcation has started. TSM has taken three

different Points and based on these points the extent of encroachment is arrived.

It is a proven fact that the accuracy of TSM is nearly perfect and the margin of error is in few centimeters. While carrying out the demarcation process, due process has been followed. The concerned villagers were also present at the time of demarcation.

That it is further pertinent to mention here that the demarcation report dated 27.03.2024 is complete and conclusive in nature as same is in consonance with the massavi of the village where land in question is situated. A copy of the massavi of the village Kanganheri, is appended herein for the kind perusal of this Hon'ble Tribunal. Copy of the same is annexed as A-4.

As per the demarcation conducted on 27.03.2024, the below mentioned Khasra Numbers has encroached upon the land falling in Khasra No. 111. The details of the encroachment is as under:

It is also pertinent to mention that for the same pond (Kh. No. 111), the demarcation was earlier carried out on 23.03.2023 and earmarking was done accordingly. Further as per demarcation findings, a demolition order vide no. SDM/KPH/STF/2023/23284 dated 10.05.2023 in respect of Khasra no. 111 (Pond) situated in the revenue estate of village Kanganheri was issued by the undersigned. The demolition drive was carried out on 15.05.2023 by this office. The demolition was carried out following the due procedure and only the unauthorized structures found to be encroaching the johad land were removed and only partially demolished owing to resistance from the inhabitants. Copy of the same is annexed as A-5.

Further, an amount of Rs 47.04 lakhs has been sanctioned by the Director (Panchayat) vide sanction order dated 29.02.2024 to I&FC for construction of boundary wall for protection of johad/pond in village kanganheri. Report in this regard is already submitted to Hon'ble Tribunal through Govt Counsel on the last date of hearing and also enclosed herewith. Copy of the same is annexed as A-6

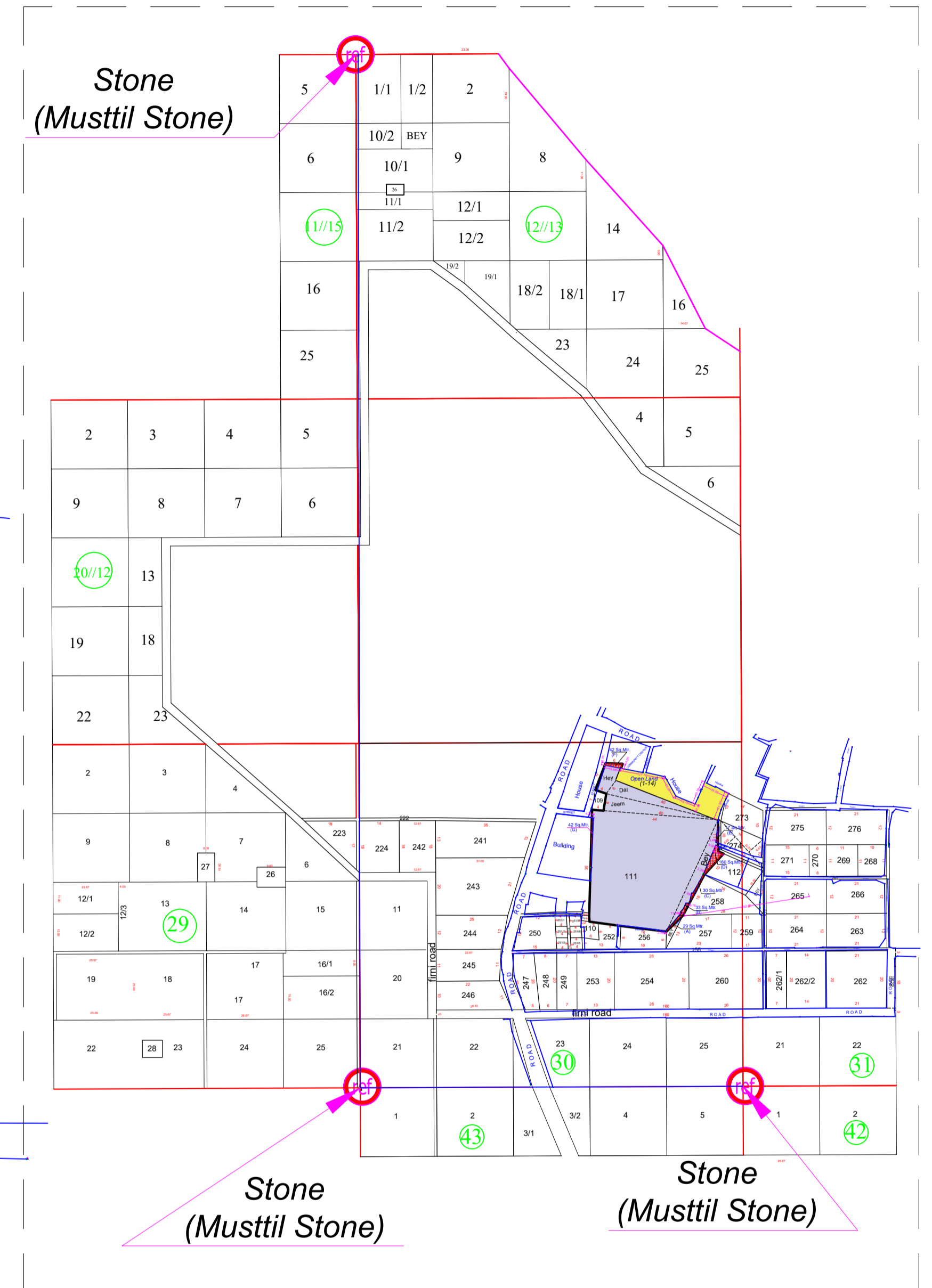
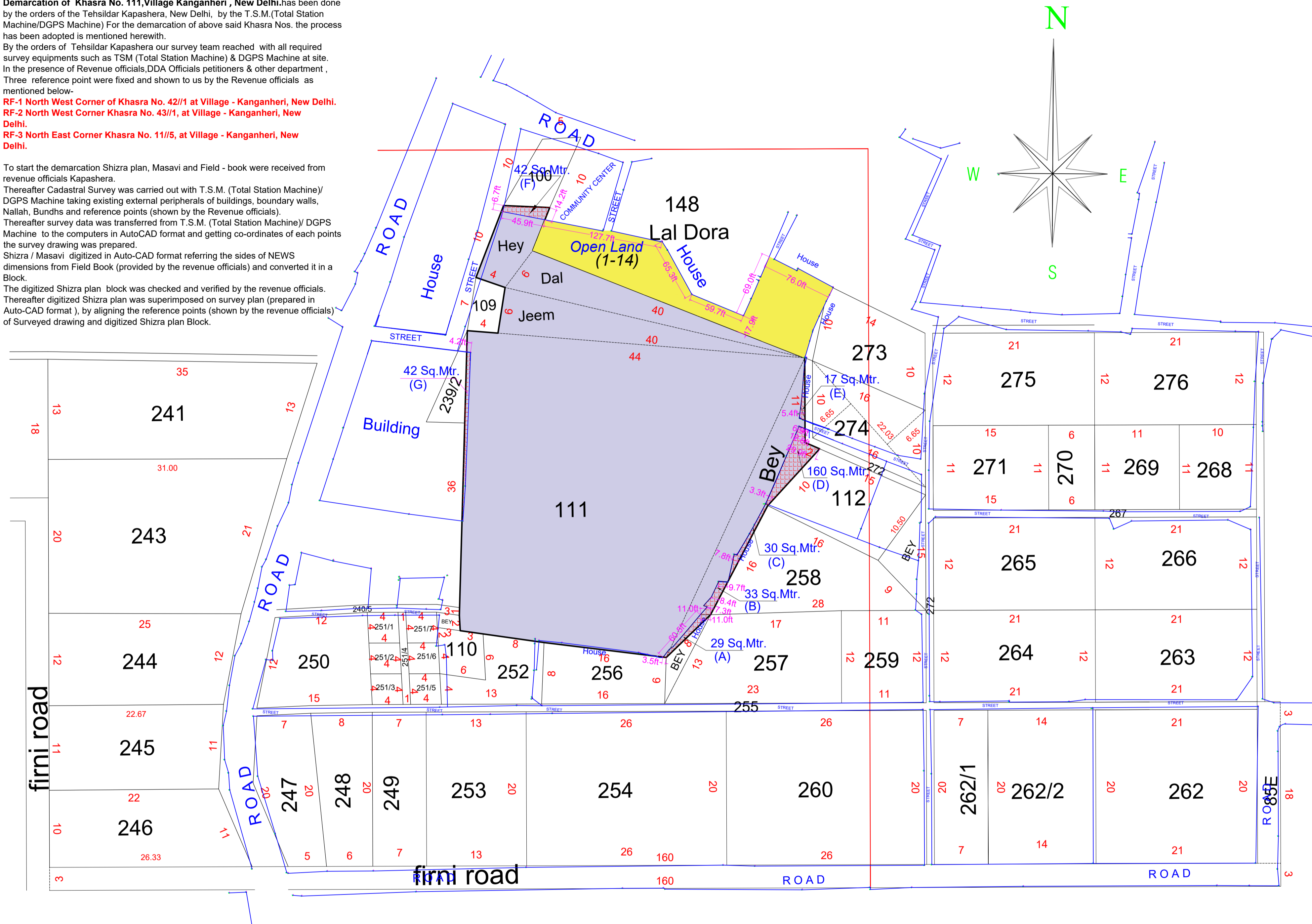

DEMARICATION PLAN OF KHASRA NO. 111, VILLAGE - KANGANHERI, NEW DELHI.

Demarcation Process:-

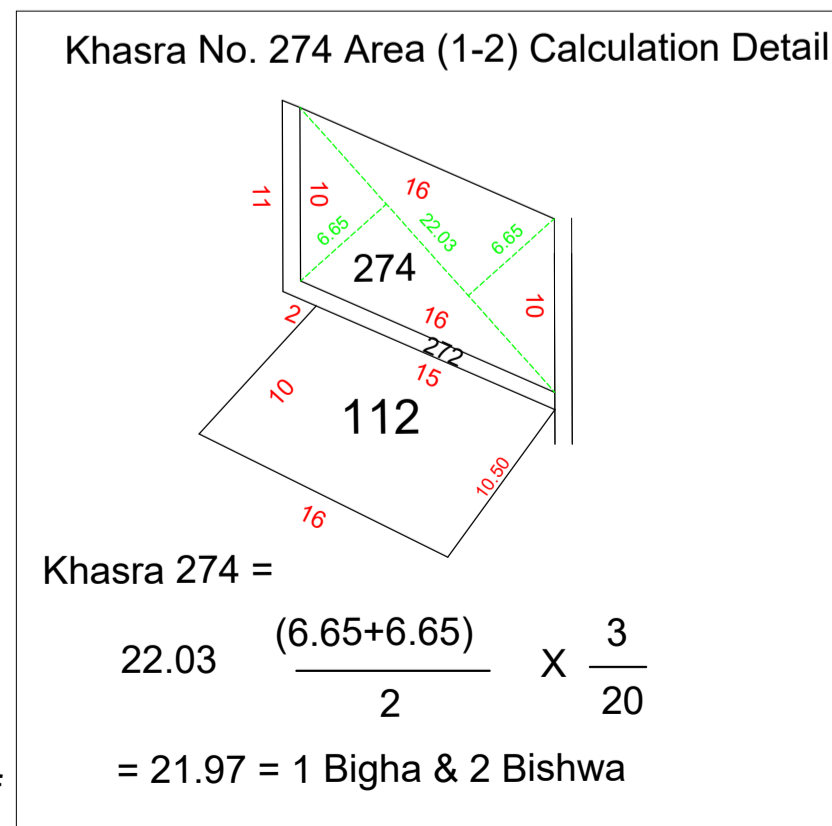
1. Demarcation of Khasra No. 111, Village Kanganheri, New Delhi, has been done by the orders of the Tehsildar Kapashera, New Delhi, by the T.S.M.(Total Station Machine/DGPS Machine) For the demarcation of above said Khasra Nos. the process has been adopted is mentioned herewith.
2. By the orders of Tehsildar Kapashera our survey team reached with all required survey equipments such as TSM (Total Station Machine) & DGPS Machine at site.
3. In the presence of Revenue officials, DDA Officials petitioners & other department, Three reference point were fixed and shown to us by the Revenue officials as mentioned below:
 RF-1 North West Corner of Khasra No. 42/1 at Village - Kanganheri, New Delhi.
 RF-2 North West Corner Khasra No. 43/1, at Village - Kanganheri, New Delhi.
 RF-3 North East Corner Khasra No. 11/5, at Village - Kanganheri, New Delhi.
4. To start the demarcation Shizra plan, Masavi and Field - book were received from revenue officials Kapashera.
5. Thereafter Cadastral Survey was carried out with T.S.M. (Total Station Machine)/ DGPS Machine taking existing external peripherals of buildings, boundary walls, Nallah, Bundhs and reference points (shown by the Revenue officials).
6. Thereafter survey data was transferred from T.S.M. (Total Station Machine)/ DGPS Machine to the computers in AutoCAD format and getting co-ordinates of each points the survey drawing was prepared.
7. Shizra / Masavi digitized in Auto-CAD format referring the sides of NEWS dimensions from Field Book (provided by the revenue officials) and converted it in a Block.
8. The digitized Shizra plan block was checked and verified by the revenue officials. Thereafter digitized Shizra plan was superimposed on survey plan (prepared in Auto-CAD format), by aligning the reference points (shown by the revenue officials) of Surveyed drawing and digitized Shizra plan Block.
