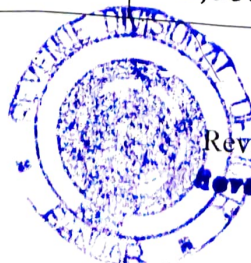

1. It is submitted that the Sri Kotari Muralidhar Babu S/o Subbarao, Kappaladoddi Village has filed Original application before the National Green Tribunal Southern Bench at Chennai vide O.A No.19/2023(SZ) with regards to the illegal mining of soil and sand in R.S.No. . 87/1, 87/2A, 88/2,86/1A, 88/4A, 88/4B, 65/5A, 65/5B, 68/2B, 95/2, 85/1A, 89/3B for total extent of Ac.30 Cts in Kappaladoddi Village of Guduru Mandal, Krishna District, Andhra Pradesh.

2. It is submitted that the Tahsildar, Guduru in whose jurisdiction the illegal mining held has reported that, while transporting busaka through tractors and tippers via Guduru village, the Tahsildar Guduru have stopped the vehicles on 10.01.2023 and enquired drivers to show permission letters, but they don't have shown any permission letters. Hence, the said vehicles bearing number AP 16 TS 6098 and AP 16 TA 6633 have been shifted to the Tahsildar's Office, Guduru Mandal immediately and warned the above Two drivers Sri Devarapalli Dayakar and Sri G.Mohan Siva Naga Dattu and also imposed a fine of Rs.2,000/- for the Tractor and Rs.3,000/- to Tipper. The drivers have paid the penalty to the Government vide challan no.s 60163173402022 and 60163136372022 on 23.01.2023 and the vehicles were released after submission of challans to their office. Statement recorded from vehicle drivers are **ANNEXURE-1**.

3. It is submitted that the Tahsildar, Guduru have stopped 6 Vehicles altogether in the year 2022 while transporting busaka and the imposed a fine of Rs.2,500/- to Rs.3,000/- to Tippers as detailed below **ANNEXURE-2**.

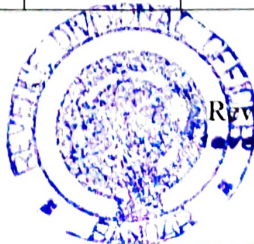

4. Further it is submitted that the Tahsildar, Guduru has furnished the details of Landowners/pattadars and their addresses and also land classification of Rs.No.87-1, 87/2A, 88-2, 86-1A, 88/4A, 88/4B, 65-5A, 65-5B, 68-2B, 95-2, 85-1A, 89-3B of Kappaladoddi village, Guduru Mandal, Krishna District to Asst Director, Mines & Geology, Vijayawada for taking further action against the illegal mining.

5. It is submitted that the the Royalty Inspector, O/o Mines & Geology, Vijayawada, Mandal along with Revenue Authorities have conducted field level enquiry and they have confirmed that illegal mining has taken place in Kappaladoddi village as detailed in the following table.

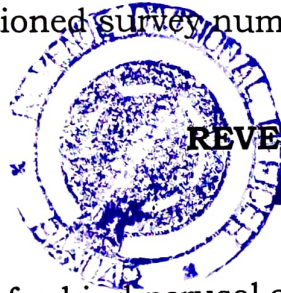

While going to Narikedalapalem for investigation for the land conversion file in Narikedalapalem village, Guduru Mandal, Krishna District, The Revenue Divisional Officer Bandaru, Tahsildar, stopped 4 sand trippers on the way and asked for an explanation from Tipper drivers for the transportation of sand. The drivers have stated that the sand was transported from Kappaladoddi village in R.S.NO.88-2A in Betala Samrajyam W/O Reddyyya's Magani farm, about 20 cents of land was dug up to a depth of 6 feet with JCB and the said sand diggers used tippers to transport the soil to Jagananna colonies. The farmer in question has received 60 cents of land through land deed number 566/1999 through SC Corporation's land purchase scheme. Four tippers were bringing locks. Further action is to submit a report.
