# REPORT OF THE JOINT COMMITTEE CONSTITUTED IN THE O.A. NO.220 OF 2022 IN THE MATTER OF COMPLIANT FILED THROUGH E-MAIL BY K. RAVINDRAN, R/O BANDLAGUDA JAGIR, GANDIPET MANDAL, RANGAREDDY DISTRICT VERSUS STATE OF TELANGANA

### 1. Introduction:

The Hon'ble NGT, New Delhi has received a complaint made by the petitioner Mr. K Ravindran resident of Madhu Park Ridge Apartment, Bandlaguda Jagir, Ranga Reddy District, Gandipet Mandal through email on 07.02.2022, stating that the human excreta is collected from the septic tanks from the surroundings residences in and around Bandlaguda Jagir Municipal Corporation and other surrounding gram panchayats and the same is being dumped into the Musi River at Tippu Khan Bridge. It is further stated that the huge quantity of the human excreta can be seen floating on the river, the filthy stench emanating from the musi river bed, is spread to the main Chevella Road and surrounding residential areas posing serious health hazards to the inhabitants of the area.

The Hon'ble NGT, New Delhi during the hearing held on 25.04.2022 passed the following Order dated 25.04.2022 in the O.A No.220 of 2022

"In view of the serious allegations made in the letter Petition, we are of the considered view that it would be appropriate to have a factual and action taken report in the matter. Accordingly, we constitute a Joint Committee comprising of State PCB, Municipal Commissioner and District Magistrate, Hyderabad. The State PCB will be the Nodal agency for coordination and compliance. The Joint Committee may meet within four weeks, undertake site visits, look into the grievances of the applicant and take requisite action by following due process of law. Factual and action taken report, which inter alia may cover the mechanism set up to evacuate septic tanks through authorized/registered agencies transporting with GPS and emptying at designated sewage pumping station or pre-identified fecal sludge treatment plant/Sewage treatment plant, may be furnished within two months"

### 2. Constitution of the Joint Committee:

In compliance with the directions of the Hon'ble NGT, the TSPCB has nominated Sri D. Krupanand, Joint Chief Environmental Engineer (JCEE) as representative of TSPCB (Annexure – I). The Revenue department, Govt. of Telangana vide letter dt: 07.07.2022 has nominated the Revenue Divisional officer, Rajendranagar Division, Rangareddy District as the representative of the District collector, Rangareddy District (Annexure – II) & the municipal commissioner, Bandlaguda jagir, RR Dist.

### 3. Terms of reference (TOR) to the Joint Committee:

 The Joint committee to meet within four weeks, undertake site visits, look into the grievances of the applicant and take requisite action by following due process of law. The Action Taken report to be furnished within 2 months by e-mail, which may cover the
mechanism set up to evacuate septic tanks through authorized / registered agencies
transporting with GPS and emptying at designated sewage pumping station or preidentified fecal sludge treatment plant / sewage treatment plant.

## 4. The JOINT COMMITTEE MEETING AND INSPECTION:

Accordingly the joint committee consisting of the following members inspected the Bandlaguda jagir, Tippu Khan Bridge on 23.06.2022 & 14.07.2022:

- Sri D. Krupanand, Joint Chief Environmental Engineer (JCEE), Telangana StatePollution Control Board (TSPCB).
- K. Chandra kala, Revenue Divisional officer, Rajendranagar Division, Rangareddy District.
- Sri. G. Venugopal Reddy, Municipal Commissioner, Bandlaguda Jagir Municipal Corporation.

During the inspection, Mr. K Ravindran, complainant and resident of Madhu Park Ridge Apartment, Bandlaguda Jagir, Ranga Reddy District and other residents of the same apartment accompanied for inspection.

The Joint Committee observed the following:

- The complainant K. Ravindran is a resident of M/s. Madhu Park Ridge Apartment, which is located at Bandlaguda Jagir, Ranga Reddy District (Co-ordinates N 17.22157" E78.405191") (photos in Annexure-IV).
- The Musi river is flowing just adjacent to M/s. Madhu Park Ridge Apartment at a distance of about 30 mtrs (photos in Annexure-IV).
- The Tippu khan Bridge is laid across the Musi river joining Chevella langer house-Gandipet road. (Co-ordinates-N17.22193", E78.24176") at a length of about 100 mtrs.
- 4. The complainant Sri K. Ravindran and other residents of the apartment have complained to the committee that during night and early morning hours some unknown persons are stopping the septic tankers filled with human excreta collected from surrounding Grampanchayat and municipal corporation and dumping directly into Musi river through flexible pipes which is leading to huge quantity of human excreta floating in the river causing severe smell nuisance to the surrounding residents of the apartment. The complainant has further stated that the municipal solid waste is also dumped into the river musi from the Tippu Khan Bridge.
- The joint committee observed that there is every possibility of dumping of human excreta into River Musi through septic tankers as stated by the complainants as there is no fencing on both sides of Tippu khan bridge.
- 6. The Municipal Commissioner, Bandlaguda Jagir has stated that the Tippu Khan Bridge does not come under the jurisdiction of the Municipal Commissioner, Bandlaguda (Annexure-III) and it comes under the jurisdiction of Greater Hyderabad Municipal

Corporation (GHMC). He further stated that he has addressed a letter to the Zonal commissioner, GHMC to erect fencing across both the sides of Tippu Khan Bridge so that the human excreta & Municipal solid waste cannot be dumped into musi river across the Tippu Khan Bridge.

- 7. The joint committee has observed that the other side of the Tippu khan bridge and M/s. Madhu Park Ridge Apartment falls under the jurisdiction of Bandlaguda jagir municipality. The committee noted that the GHMC limits starts from the starting point of Tippu Khan Bridge.
- 8. The Municipal, Commissioner, Bandlaguda Jagir has also stated that the Bandlaguda Municipal Corporation in support with M/s. Madhu Park Ridge Apartment are planning to install CC Cameras and the sanitation team of Bandlaguda Municipality are regularly cleaning the surroundings of Tippu Khan Bridge for maintaining cleaner surroundings (photos in Annexure-IV).
- 9. The Joint committee also noted that the authority for regulating the septic tankers for collection and disposal of human excreta is the Hyderabad Metro Water Supply & Sewerage Board (HMWS&SB) in the GHMC area and in Municipal areas the concerned authority is Commissioner & Director Municipal Administration (CDMA). The HMWS&SB/CDMA authorizes /issues licenses for collection and transportation of fecal matter through septic tankers which shall have GPS tracking system. The septic tankers shall collect human excreta form septic tanks of surroundings areas and the same shall be disposed in Fecal Sludge Treatment plants (FSTPs) / STPs maintained and operated by HMWS&SB.
- 10. The joint committee has observed that the problem of the residents of M/s. Madhu Park Ridge Apartment can be addressed by the following:
  - By erecting fencing across both sides of Tippu Khan Bridge to a minimum height of 10 to 12 feet, so that human excreta/municipal solid waste cannot be dumped in to river Musi.
  - Lifting of human excreta shall be permitted through the tankers which are having
    GPS tracking system and which are authorized by HMWS&SB/CDMA and the
    collected human excreta shall be treated and disposed at Fecal Sludge Treatment
    plants (FSTPs)/STPs (sewage treatments plants) maintained and operated by
    Hyderabad Metro Water Supply & Sewerage Board (HMWS&SB) for further
    treatment and disposal.
  - By installing CCTV cameras across the Tippu Khan Bridge to curtail the un authorized dumping of human excreta/ Municipal solid waste in to Musi River.
  - By maintaining cleaner environment in the surroundings of Tippu Khan Bridge
     by regular cleaning /lifting of solid waste by Bandla guda jagir municipality.



# 5. RECOMMENDATIONS OF THE JOINT COMMITTEE:

- The GHMC / Musi River Front Development Corporation Limited (MRFDCL)
  shall erect fencing across both sides of Tippu Khan Bridge to a minimum height of 10 to
  12 feet, so that human excreta/municipal solid waste cannot be dumped into river Musi.
- The HMWS&SB/CDMA shall ensure that the septic tankers shall have permission and also GPS tracking system to the tankers for collection and disposal of human excreta transported to Fecal Sludge Treatment plants (FSTPs)/STPs (sewage treatments plants) maintained and operated by HMWS&SB.
- The GHMC/Bandlaguda jagir municipality shall ensure that there is no authorized septic tanker movement in their jurisdiction.
- 4. The GHMC /Bandlaguda jagir municipality shall install CCTV cameras across the Tippu Khan Bridge so as to prevent unauthorized dumping of Human excreta / Municipal solid waste in to Musi river.

The filthy stench emanating from the river bed is spread to the main Chevela Road and surrounding residential areas posing serious health hazards to the inhabitants of the area.

The above case was taken up as OA by the Hon'ble NGT, New Delhi during the hearing held on 25.04.2022. The relevant extract of the Hon'ble NGT Order is as follows: -

ORDER

2. In view of the serious allegations made in the letter Petition, we are of the considered view that it would be appropriate to have a factual and action taken report in the matter. Accordingly, we constitute a Joint Committee comprising of State PCB, Municipal Commissioner and District Magistrate, Hyderabad. The State PCB will be the Nodal agency for coordination and compliance. The Joint Committee may meet within four weeks, undertake site visits, look into the grievances of the applicant and take requisite action by following due process of law. Factual and action taken report, which inter alia may cover the mechanism set up to evacuate septic tanks through authorized/registered agencies transporting with GPS and emptying at designated sewage pumping station or pre-identified fecal sludge treatment plant/Sewage treatment plant, may be furnished within two months by e-mail at judicialngt@gov.in preferably in the form of searchable PDF/OCR Support PDF and not in the form of Image PDF.

With reference to the subject cited, it is to inform you that based on letter petition made by Sri. K. Ravindran, R/o. Bandlaguda Jagir, Gandipet Mandal, RR Dist. registered before the Hon'ble NGT, New Delhi, regarding the human excreta collected from the septic tanks of residence in and around the area of Bandlaguda Jagir Municipal Corporation and other surrounding gram panchayats is being dumped into the Musi River at Tippu Khan Bridge.

In this regard Vide ref 1st cited, TSPCB, Hyderabad has appointed a Joint Committee comprising of following:

- 1) State PCB (Nodal Agency for coordination and logistics)
- 2) Municipal Commissioner, Bandlaguda Jagir Municipal Corporation
- 3) District Collector, Ranga Reddy Dist.

Accordingly, vide ref 4th cited, Joint Committee inspection is Scheduled on 23.06.2022 with Sri. D. Krupanand, JCEE-Zonal office, TSPCB Hyderabad along with

Municipal Commissioner, Bandlaguda Jagir Municipal Corporation. In this Joint inspection there are three major issues identified as follows:

- to erect fencing across the both sides of Tippu Khan Bridge, So that, human excreta collected from the septic tanks may not be dumped into the Musi River across the Tippu Khan Bridge
- 2) To install CCTV cameras across the Tippu Khan Bridge.
- 3) To clean the surroundings of Tippu Khan Bridge.

In view of the above vide ref 2<sup>nd</sup> cited this office has requested the Zonal Commissioner, Central Zone, GHMC to erect fencing across the both sides of Tippu Khan Bridge, so that, human excreta collected from the septic tanks may not be dumped into the Musi River across the Tippu Khan Bridge. (Tippu Khan Bridge under the jurisdiction of Greater Hyderabad Municipal Corporation) and on our part we are installing CCTV Cameras with the support of Madhu Park Apartment and further the surroundings of Tippu Khan Bridge will be made clean with our sanitation team.

Therefore, I am herewith submitting the Joint committee inspection and compliance report for the complaint filed and in addition, I further submit that Tippu Khan bridge doesn't come under my jurisdiction, it comes under GHMC limits. 



- 1. The grievances in the present letter petition made by Mr. K Ravindran resident of Madhu Park Ridge Apartment, Bandlaguda Jagir, Ranga Reddy District, Gandipet Mandal are that the human excreta is collected from the septic tanks of residences in and around the area of Bandlaguda Jagir Municipal Corporation and other surrounding gram panchayats is being dumped into the Musi River at Tippu Khan Bridge. It is further stated that the huge quantity of the human excreta can be seen floating on the river. The filthy stench emanating from the river bed is spread to the main Chevela Road and surrounding residential areas posing serious health hazards to the inhabitants of the area.
- 2. In view of the serious allegations made in the letter Petition, we are of the considered view that it would be appropriate to have a factual and action taken report in the matter. Accordingly, we constitute a Joint

Committee comprising of State PCB, Municipal Commissioner and

District Magistrate, Hyderabad. The State PCB will be the Nodal agency

for coordination and compliance. The Joint Committee may meet within

four weeks, undertake site visits, look into the grievances of the applicant
