UPON hearing the counsel the Court made the following O R D E R

- 1 The Interlocutory Application for impleadment (IA No 40462/2023) is allowed.
- The Interlocutory Applications are to seek a stay on the expansion of the capacity of the Waste to Energy Plant at Okhla from 23 MW to 40 MW.
- Mr Ranjit Kumar, senior counsel appearing on behalf of the Ninth Respondent states that in pursuance of the permission which has been received, the process of expansion and operationalising the plant to the enhanced capacity would take about 18 months.
- In view of the above statement of Mr Ranjit Kumar, it is not necessary to entertain the Interlocutory Applications at the present stage.
- However we have acceded to the request of all the counsel that the Civil Appeal be listed for final disposal at an early date.
- 6 List the Civil Appeal along with IA No 49339 of 2023 on 19 July 2023.
- 7 Any steps which are taken by the concessioner towards implementing the

permission for enhancement of the capacity from 23 MW to 40 MW shall be

subject to the final result of the appeal and shall not create any equities.

8 To facilitate the final disposal of the proceedings, counsel appearing on behalf of

the contesting parties shall prepare a common compilation of documentary and

other material that is sought to be relied upon.

9 Mr Devvrat, counsel for the appellant and Mr Nilava Bandyopadhyay, counsel

assisting Mr Ranjit Kumar shall act as nodal counsel to ensure that soft copies of

the compilations are prepared and circulated to the Bench and to the counsel

appearing on behalf of the contesting parties. The soft copies of the

compilations shall also be emailed to cmvc.dyc@gmail.com.

10 Parties shall also file brief sets of written submissions by 30 June 2023.

11 IA Nos 10266, 40464, and 40945 are accordingly disposed of.
