The State PCB will be the Nodal agency for coordination and compliance. The Joint Committee may meet within four weeks and undertake site visit and look into the grievance of the applicant and take appropriate action. Factual and action taken report may be furnished within two months by e-mail at judicial-ngt@gov.in preferably in the form of searchable PDF/OCR Support PDF and not in the form of Image PDF

In compliance to the order dated 10.04.2022 of Hon'ble NGT O.A No.173/2022 titled Ram Singh V s State of H.P., vide which the joint committee has been constituted by the Hon'ble NGT i.e. State PCB (Nodal Agency), Conservator of Forest, Kangra and Distt. Magistrate Distt. Lahaul & Spiti and directed to submit factual and action take report in time bound manner.

This is with reference to H.P. State Pollution Control Board letter No.PCB/NGT/O.A. No. 173/2022 -1317-19 dated 26.04 2022(Copy enclosed as Annexure-A) and with reference to Regional office HPSPCB Kullu the letter No. PCB RO Kullu/(1650)/NGT file/Vol-X/2022-295-98 dated 29.04.2022 (Copy enclosed as Annexure-B) vide which Joint Committee has been requested to conduct joint inspection and submit joint factual/action taken report of areas as per direction passed by Hon'ble NGT.

In this regard, the Representative of State PCB, Regional Officer, Rampur, Distt. Shimla has coordinated with Joint Committee and the said area i.e. Poah-Maidan to Helipad has been inspected by the committee on 12.05.2022. During inspection, it has been observed that Executive Engineer, HPPWD Division Kaza, Distt Lahaul Spiti, H.P. has constructed and widened by back cutting road named Poah-Maidan to Helipad having a length of 12.240 Kms.

Further, the Joint Committee decided to constitute a sub-committee comprising Revenue Deptt., HPPWD. Deptt. and Forest Deptt. for taking measurements of actual road constructed on spot by HPPWD vise vis approval conveyed by Forest Department under the provisions of Forest Right Act,2006 and submit detailed/Factual report before the joint inspection committee (Copy enclosed as Annexure-C).

The Sub-Committee report is attached as Annexure-V.

In addition to above, Addl. Deputy Commission, Kaza has informed the complainant vide letter No. 455/PA on dated 11<sup>th</sup> May, 2022 ( Copy enclosed as Annexure-VI ) requested to present personally on above mentioned date, time and venue. But he didn't attended the joint inspection. On the same day at the time of joint inspection the Chief Conservator of Forests, Dharamshala contacted the complainant on mobile phone and discussed the matter regarding his absence from joint inspection. The complainant said he is at Bilaspur and will not be able to attend the said inspection. Further the committee decided that ADC Kaza will record the statement of Complainant. On this Addl. Deputy Commissioner, Kaza vide letter No.461 dated 12.05.2022 (Annexure-VII) requested the complainant to be present in his office to discuss about the above case. The complainant attend the office/ of Addl. Deputy Commissioner, Kaza on dated 12.05.2022 and reiterated the matter that he had stated in his complaint.

1. It is observed from the above table that the DFO(Wild Life) Kaza have accorded approval for construction of road under Forest Right Act, 2006 for 9.400 Kms in piece meal i.e. four times for continuous/ linear road.

2. The road constructed from Gecha to Helipad i.e. 2.840 Kms have not been approved under Forest Right Act by DFO (Wild Life) Kaza & the road have been constructed without the any approval by XEN, HPPWD, Spiti at Kaza.

3. The total road constructed on spot has been inspected by the Committee & the Sub-Committee constituted for the measurement of already constructed road has submitted its report that total length 12.240 Kms has been constructed on spot from Pop-maidan to Helipad.

4. The 1<sup>st</sup> approval has been accorded by DFO (Wild Life) Kaza vide his office No. 480 dated 08.08.2018 for construction of jeepable road from Soman to Nyupur from 0.000 to 3/000 for

0.2625 Ha Forest land. This approval was well within the power of DFO (Wild Life), Kaza as one time approval.

5. The next three approvals accorded by DFO (Wild Life) Kaza for construction of jeepable road is given as under :-

6. It is submitted that the approval has been granted for one road upto 9.400 Kms in parts i.e. by issuing four approval orders by DFO (Wild Life), Kaza.

7. It is clear that out of 12.240 Kms road continuously constructed on spot from Pohmaidan to Helipad the approval of constructed road for FRA has been obtain by XEN HPPWD Kaza from DFO (Wild Life) Kaza only for 9.400 Kms length , but all the four approvals granted by DFO (Wild Life) Kaza is for a linear road which is in contravention of Forest Right Act,2006. The additional 2.840 Kms road length from Gecha to Helipad has also been constructed illegally by XEN,HPPWD, Spiti at Kaza for which no approval have been obtained by XEN.HPPWD, Spiti at Kaza.

the recommendations of Committee:-

Since the road has been constructed between Poh-maidan to Helipad having total length of 12.240 Kms by XEN, HPPWD, Splti at Kaza is in contravention of provisions given under Forest Right Act, 2006, as all approvals are part of linear project/road. It needs proper diversion of Forest Land for non-forestry purpose under Forest Conservation Act, 1980.

The area fall under the border, hard & Tribal area and connectivity for communication is essential in this area. Keeping in view of the larger interest of public, the XEN, HPPWD, Spiti at Kaza may kindly be directed to apply for diversion of Forest Land for non-forestry purpose under Forest Conservation Act, 1980 for getting approval for diversion of Forest land in this case.

The XEN, HPPWD, Spiti at Kaza may kindly be allowed to prepare FCA case for diversion of Forest Land for non forestry pupose from Poh-maidan to Helipad for the total length 12.240Kms which has already been constructed by the XEN, HPPWD, Spiti at Kaza.
