ORDER

Original Application No. 525/2016 (Earlier O.A. No.72/2014)

This matter raises the issue of directions for installing RWH system which subject has been dealt with in the order passed today in O.A. No. 496/2016, News Item Published in "Hindustan Times" dated 19.06.2015 titled "Dirty flows your drinking water" authored by Ritam Halder". No separate argument has been addressed in this matter. No separate order is necessary.

The application is disposed of.

Execution Application No. 05/2018 In O.A. No. 217/2016

This application seeks enforcement of order dated 16.11.2017 in O.A. No. 217 of 2016 directing all the schools and colleges in Delhi to install RWH systems within two months from the date of the order failing which compensation of Rs. 5 lakhs will be required to be paid. Vide order dated 30.01.2019, the Tribunal directed recovery of compensation from the schools and colleges which have not complied with the order of the Tribunal. On 20.02.2019, this Tribunal dismissed applications of non-compliant schools seeking waiver of environmental compensation and directed the Department to take steps for compliance of the direction of this Tribunal. Similar order was passed on 13.03.2019.

In view of order passed today in O.A. No. 496/2016, News Item Published in "Hindustan Times" dated 19.06.2015 titled "Dirty flows your drinking water" authored by Ritam Halder", no separate order is

necessary in this matter. The Authorities may enforce the order of this Tribunal dated 16.11.2017 and furnish a report before the Committee constituted by this Tribunal in O.A. No. 496/2016. We have noticed orders of Hon'ble Supreme Court in C.A No. 5831-33/2019 filed by *South Delhi Municipal Corporation v. Mahesh Chandra Saxena & Ors.* against order dated 30.01.2019. The aspects on the subject matter of the said appeals or any other such appeals will abide by orders of Hon'ble Supreme Court.

The application is disposed of.

I.A. No. 168/2019, M.A. No. 98/2019 and I.A. No. 174/2019 in Execution Application No. 05/2018

These applications have been filed for waiver of compensation directed to be paid in terms of order dated 16.11.2017 passed in O.A. No. 217/2016 and order dated 30.01.2019 passed in E.A. No. 5/2018. No ground has been made out for such waiver in the light of earlier orders of this Tribunal.

The applications are dismissed.

Review Applications No. 25/2019, 26/2019 & 27/2019

These applications are for review of order dated 16.11.2017. We have perused the review applications. No ground is made out for review in view of earlier orders rejecting such prayers.

The applications stand disposed of.

Original Application No. 70/2018
