## Subject: Compliance of order dated 02.02.2023 passed by the Hon'ble NGT in O.A No. 673/2018.

Briefly stated, the Hon'ble National Green Tribunal Principal Bench, New Delhi, vide orders dated 02.02.2023 passed in Execution Application no. 1/2023 filed in Original Application No. 673/2018-News item published in "**The Hindu**" **authored by Shri Jacob Koshy titled "More river stretches are now critically polluted: CPCB** has considered the issue of water pollution in river Satluj near Gurudwara Patalpuri Sahib at Kiratpur Sahib, District Rupnagar and directed the Chief Secretary, State Pollution Control Board and District Magistrate Rupnagar to look into the issue raised and take remedial action in accordance with law and the undersigned being Chief Secretary, Punjab has been asked to file an action taken report with the Registrar General of the Hon'ble Tribunal within one month.

In compliance to the order dated 02.02.2023 of the Hon'ble Tribunal, it is respectfully submitted that the site in question was visited by the officer of Punjab Pollution Control Board on 11.01.2023 and observed that domestic effluent of Kiratpur Sahib is being discharged into River Sutlej. The officer of Punjab Water Supply and Sewerage Board was contacted by the visiting officer and it came to fore that the tender for construction of Sewage Treatment Plant (STP) of capacity of 2 MLD at Kiratpur Sahib has been called many times but the rates quoted by the contractor were too high, as such, the competent authority of the Punjab Water Supply and Sewerage Bard (PWSSB) has not accepted the rates quoted by the contractor.

On the observations of the visiting officer, the Punjab Pollution Control Board had issued notice u/s 33-A of the Water (Prevention & Control of Pollution) Act, 1974 vide letter no. 1043 dated 09.02.2023 to the Executive Officer, Nagar Panchayat, Kiratpur Sahib and the Executive Engineer, Punjab Water Supply and Sewerage Board along-with an opportunity of personal hearing on 21.02.2023 before the Chairman of the Board.

Sh. Harbaksh Singh, Executive Officer, Nagar Panchayat, Kiratpur Sahib alongwith Rahul Kaushal, Executive Engineer, PWSSB had appeared for hearing before the Chairman, Punjab Pollution Control Board on 21.2.2023. Executive Officer, Nagar Panchayat, Kiratpur Sahib submitted in writing that the Government has already transferred the funds to Punjab Water Supply and Sewerage Board for construction of Main Pumping Station (MPS) and Sewage Treatment Plant (STP). The PWSSB has already constructed MPS but STP is yet to be constructed. Nagar Panchayat has also given the revised consents after passing resolution 107 dated 13.02.2023 on the request of PWSSB. The EO, Kiratpur Sahib vide letter no. 198 dated 20.02.2023 assured to provide more funds to PWSSB, if required. The representative of PWSSB informed that revised Detailed Notice Inviting Tender (DNIT) is under process. The PWSSB has called tenders 12 times, for this project however.

the bid could not be accepted as bids were 30-40% more than the reserved price. After hearing, the Chairman, Punjab Pollution Control Board has decided to impose Environmental Compensation and to request the department of Local Government to initiate suitable action against the EO, Nagar Panchayat, Kiratpur Sahib and other responsible officers/officials for dereliction of duty.

The Deputy Commissioner, Rupnagar had issued interim order no. 1076-1080 dated 28.03.2023 whereby, Executive Engineer, Punjab Water Supply and Sewerage Division, Rupnagar has been directed to complete the work of STP by June, 2024 by following due procedure. Besides, the Punjab Water Supply and Sewerage Board has been directed to maintain temporary measures already adopted for treatment of domestic effluent till STP is commissioned. The temporary measures will be monitored by the Environmental Engineer, Punjab Pollution Control Board to ensure the compliance of the directions of Hon'ble NGT and that Executive Engineer, Punjab Water Supply and Sewerage Division, Rupnagar will be held responsible if pollution in river Sutlej near Gurudwara Patalpuri Sahib is again reported.

The Department of Environment has also impressed upon the Department of Local Government by writing a demi official letter dated 5.5.2023 (Annexure-A) to complete the installation and commissioning of Sewage Treatment Plant at Kiratpur Sahib by June, 2024 so as to contain the cause of water pollution near Gurudwara Patalpuri Sahib. In reference to said D.O letter dated 5.5.2023, the Engineer-in-Chief-cum-Technical Advisor, Punjab Water Supply and Sewerage Board vide letter dated 22.5.2023 (Annexure-B) has forwarded the assurance given by Executive Engineer, Punjab Water Supply and Sewerage Board to the Secretary to Government of Punjab, Department of Science, Technology and Environment that the tender has been again called on 22.5.2023 with opening date of 13.6.2023. After allotment, the work is to be completed within 9 months and in all possibility the work will be completed by 30.6.2024.

The authorities will ensure compliance in this regard.

The action taken report is being submitted in compliance to order dated 2.2.2023 passed in O.A No. 673 of 2018.

The Deputy Commissioner, Rupnagar had also issued interim order no. 1076-1080 dated 28.03.2023 (copy enclosed) whereby, Executive Engineer, Punjab Water Supply and Sewerage Division has been directed to complete the work of STP at Kiratpur Sahib by Junc, 2024 by following the due procedure. Besides, it has also been directed to maintain temporary measures adopted for treatment of domestic effluent till STP is commissioned. The temporary measures will be monitored by the Environmental Engineer, Punjab Pollution Control Board to ensure the compliance of the directions of Hon'ble NGT and that Executive Engineer, Punjab Water Supply and Sewerage Division, Rupnagar will be held responsible if pollution in river Sutlej near Gurudwara Patalpuri Sahib is again reported.
