and state on oath as under

- 1. That I am presently working as _______ SE/SCC2__ of Respondent DDA and as such am duly authorised and competent to affirm the present affidavit on behalf of Delhi Development Authority.
- 2. That the instant affidavit has been drafted under my instructions and I say that the facts therein are based upon case records which I believe to be accurate to the best of my knowledge and belief.

It is submitted that the Hon'ble Tribunal vide Order dated 03.03.2023 took cognisance of the compliance report dated 14.11.2022 and additional compliance report dated 02.03.2023 filed by DDA underlining steps taken by the latter to address issues

pertaining to the present O.A. However, vide the same Order, the Hon'ble Tribunal further directed DDA to file a detailed compliance report reflecting the action plan devised to resolve issues inherent to the present O.A.

4. In compliance with the Hon'ble Tribunal's Order dated 03.03.2023, DDA held a meeting between representatives of DPCC along with the Applicant Mr D.S. Kataria and the rest of the residents of the said society on 11.04.2023 so as to review the status of actions undertaken in the previous compliance reports. The meeting was held to address issues pertaining to two cases viz., O.A. 17/2022 and O.A. 517/2022, both pending adjudication before the Hon'ble Tribunal on 30.05.2023.

True copy of the Minutes of the Meeting dated 18.04.2023 is enclosed herewith and marked as **Annexure A-1**.

5. In the said meeting dated 11.04.2023 held in the office of the RWA, Sector E-2, Vasant Kunj, grievances pertaining to the instant case raised by residents of the subject society along with the corresponding action taken by DDA are delineated hereinunder:

Grievances Raised

The ditch created behind the subject society to resolve the issue of waterlogging during the rainy season is in an unhygienic condition due to sewer/drain water being incessantly discharged from the unauthorised drain of K-2 Block, Village Mahipalpur.

Action Taken by DDA

DDA had floated a tender for the construction of an RCC wall behind subject society to prevent the seepage of dirty water into the said society which was awarded to M/s S. Kumar & Company on 24.05.2023 for an amount of Rs. 36,13,779 and a work duration of 45 days. Further, the construction of a drain to prevent the stagnation of sewage water has also been contemplated.

Pertinent to state that DDA has

	already completed the water-proofing treatment and strengthening of the boundary wall of the society that runs along the drain in compliance with DPCC's directions vide letter dated 28.06.2022.
Cleaning of the pond is not carried out routinely.	The pond has already been cleaned in 2022 as per the directions of DPCC and photographs of the same were submitted before this Hon'ble Tribunal vide Additional Compliance Affidavit dated 02.03.2023. DDA had further submitted that it has issued a fresh tender for further routine cleaning of the pond/waterlogged area. The said tender was floated on 13.03.2023 and awarded to M/s Dhruv Parmanik on 27.04.2023 for an amount of Rs. 12,62,338 and a work duration of 45 days. The work has already commenced on site. Photographs of the clean land are enclosed along with this affidavit.

True copies of the tenders awarded for the construction of the RCC wall behind the subject society and cleaning of waste/malba around the waterlogged area/pond at Rangpuri Pahari along with recent Photographs captured of the said area are enclosed herewith and marked as **Annexure A-2 (Colly)**.

6. Although not raised as an active grievance in the aforesaid meeting, it is submitted that DDA had also cleaned the *malba*

and/or garbage around the waterlogged area/pond at Rangpuri Pahadi which falls in the approach of Runway-28 and deputed a security guard to keep strict vigil in compliance with DPCC's directions vide letter dated 28.04.2022. The same was submitted before this Hon'ble Tribunal vide Additional Compliance Affidavit dated 02.03.2023. Thereafter, since the running tender for the deployment of the security guard expired in January 2023, DDA has taken steps to clean the entire area so as to prevent the illegal dumping of waste/malba. Further, it is reiterated that DDA has already awarded the tender for cleaning waste/malba around the waterlogged area/pond at Rangpuri Pahadi to M/s Dhruv Parmanik for an amount of Rs. 12,62,338 and a work duration of 45 days.

7. That in light of the aforesaid, DDA has discharged its compliance with DPCC's and this Hon'ble Tribunal's directions pertaining to issues raised by the Applicants in the captioned O.A.

Versus Govt. of NCT of Delhi** for review of action taken status of the work executed by DDA, a meeting was held on 11.04.2023 at 11.00 AM in the office of RWA, Sector E-2, Vasant Kunj between the representatives of DPCC, RWA & DDA in the presence of following:-

In the above meeting, following grievances of the residents were discussed in the matter of DS Kataria & Ors. Versus Govt. of NCT of Delhi i.e. OA No. 17/2022 and OA No. 517/2022:-

SL. NO.	GRIEVANCES RAISED	ACTION TAKEN BY DDA
1.	During rainy season, the E-2 pocket is facing water logging issue, therefore, an artificial ditch created adjoining to Pkt. E-2 to resolve the issue of water logging, but the sewerage / drain water continuously enter in said area from unauthorized nallah of K-2 Block, Village Mahipalpur, which creates unhygienic conditions.	The water proofing work of existing RR wall of Pocket E-2 was already completed by the then staff in October-2022 and the same was submitted in the Hon'ble Court. As per direction of DPCC, this office has also floated a tender for RCC wall to prevent the unhygienic water comes in the said land.
2.	The cleaning of pond is not done on regular basis.	The pond was already cleaned in the year -2022 by then staff of DDA and the same was submitted before the Hon'ble Court and as per request o RWA and DPCC. Furthermore, this office has already started the work fo cleaning of pond.



The issue of barricading pertains to The Heavy vehicles / trucks are 3. continuously passing through E-1 & Traffic Police, Delhi. E-2 Road, which causes dust and sound pollution. Therefore, a height barrier is to be installed on E-1 & E-2 road to restrict the entry of heavy vehicles. However, this road was constructed by DDA exclusively for E-1 & E-2 pocket only. There are also securities issues in late night The work for sprinkling of water was DDA has stopped daily sprinkling of 4. completed in the month of March-2023 water on the road of E-1 & E-2 & as per direction of DPCC, this office will again float a tender for the same as soon as possible.


