Learned counsel for the petitioner states that the respondents-authorities should be asked to examine the Report given by the IIT, Mumbai, order of the NGT dated 20<sup>th</sup> January, 2017 and Notification dated 31<sup>st</sup> July, 2014.

We are informed that the Maharashtra Pollution Control Board has installed pollution monitors in the area in question.
