#### ALLOCATION OF FUNDS FOR PM KUSUM

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) the amount (in ₹) allocated to Pradhan Mantri Kisan Urja Suraksha Evam Utthaan Mahabhiyan (PM KUSUM) scheme since its inception in 2019, year-wise;
- (b) the progress made by the scheme from March 2019 to July 2024, State-wise; and
- (c) the targets achieved by the scheme (in percentage) from 2019 to July 2024, year-wise?

#### ANSWER

# THE MINISTER OF STATE FOR NEW & RENEWABLE ENERGY AND POWER (SHRI SHRIPAD YESSO NAIK)

- (a) The Financial Year-wise allocation to the Pradhan Mantri Kisan Urja Suraksha Evam Utthaan Mahabhiyan (PM KUSUM) scheme since its inception in 2019 is enclosed at **Annexure-I.**
- (b) & (c) The Government launched PM KUSUM scheme in March, 2019 and issued the implementation guidelines in July 2019. Additionally, the scheme was scaled-up in November 2020 and again in January 2024, and the targets were revised to the installation of 10,000 MW of Decentralized Ground/ Stilt Mounted Grid Connected Solar or other Renewable Energy based Power Plants by the farmers on their land under Component-A, Installation of 14 Lakh Stand-alone Solar Agriculture Pumps under Component-B, and Solarisation of 35 Lakh Grid Connected Agriculture Pumps including Feeder Level Solarization under Component-C. The scheme has been extended till 31.03.2026.

The State-wise progress under the PM-KUSUM scheme as on 30.06.2024 is enclosed at **Annexure-II**.

PM-KUSUM Scheme is a demand driven scheme and no year-wise targets are established or given to the States. The allocations are made based on the demand received from States. However, the sanction under the scheme is presently valid for 24 months from the date of the sanction, within which States have to complete the installation. The year wise achievements from 2019-20 onwards under the different components, as on 30.06.2024, is enclosed at **Annexure-III**.
