REPLY STATEMENT IN OA 184/22 FILED BY SRI. M.N. JAYACHANDRAN BEFORE THE NATIONAL GREEN TRIBUNAL PRINCIPAL BENCH, NEW DELHI

This petition is filed by Sri. M. N. Jayachandran alleging that Sri. Biji P. Mathew is running tourism activities in the encroached area of the Periyar Tiger Reserve and elephant rides in Idukki District using more than 10 elephants, which is banned by District Collector.

It is true that Sri. Biji P Mathew is running an elephant ride named 'Elephant Camp' in Kumili, Idukki District. OR-021/2022 of Peermade Forest Range is registered against Sri. Biji P. Mathew against the violation of Kerala Captive Elephants (Management and Maintenance) Rules 2012 in 'Elephant Camp'. Copy of the Form-l Report submitted before the JFCMC, Peermade is enclosed herewith as Exhibit R1(1). Another OR-031/2022 of Peermade Forest Range is registered against him for violation of Kerala Captive Elephants (Management and Maintenance) Rules 2012 for conducting elephant rides in Tusker Train Elephant Camp Kumily, Ist Mile. Copy of the Form - I Report submitted before the JFCMC, Peermade is produced herewith as Exhibit R1(2). The final charge sheets are yet to be filed before the jurisdictional Courts. It is true that there are three more elephant camps functioning around the Periyar Tiger Reserve and about 20 elephants are there in these camps. No elephant rides are being conducted inside the sanctuary. As per interim order dated 05.09.2019 in WP (C) 13275/2019, the Hon'ble High Court of Kerala directed the District Collector, Idukki who is the Chairman of the District Committee under Kerala Captive Elephants (Management and Maintenance) Rules 2012 to take necessary steps to ensure that elephant rides using elephants not registered under the Performing Animals (Registration) Rules 2001 are not conducted in Idukki District, during the pendency of the Writ petition.

As per the report of Kerala State Pollution Control Board dated 16.11.2022, all the waste water discharge to the streams has been stopped and no discharge of waste water was found during the second visit of the joint committee on 21.10.2022.

It is submitted that there were death of two captive female elephants named 'Rambha' and 'Dulari' duing 2022 in ldukki District. The cause of death of 'Rambha' was severe pyometra leading to peritonitis and systemic failure. Copy of the Post Mortem Report is submitted herewith as **Exhibit R1(3)**. The cause of death of 'Dulari' was due to senile lesions leading to multi organ failure. Copy of the Post Mortem Report is submitted herewith as **Exhibit R1(4)**.

The petitioner Mr. M.N. Jayachandran as claimed in the petition is not an office bearer of the registered SPCA's of Idukki District. As per the new Government Order G.O(Rt) No.194/2022/AHD dated 13/04/2022, the powers for formation of SPCA has been entrusted with District Panchayat and it is up to the President of the District Panchayath to reconstitute the District SPCA. Copy of the Government Order is submitted herewith as **Exhibit R1(5)**.

POST MORTEM REPORT

Certified that necropsy examination was conducted on the body of female elephant RAMENA aged around 44 years, memo:0006507CA3 (Enstodian Thomas Mathew, Mailayckal, Kappaduj-in 18/11/22,005 pm, Murtikkadi, Kumily (GPS No 9*37',*E,77* 8'35'') on request by social forestry range, Kumily.

CLINICAL HISTORY: This animal was under metrilis treatment since few months, refractoriness to treatment, and died on 14/11/22 (11.30 pm) not responding to treatment.

EXTERNAL FINDINGS: The body of female elephant aged around 44 years in emorated condition was seen in lateral recumbency. There was exudation of mucus from oral cavity, right-mortis passed, skin and appendages normal, bloated abdomen, enlarged superficial lymph modes and right tush missing.

INTERNAL FINDINGS: On examination of visceral organs, following observations were made

Oral cavity- Pale with mucus exudate.

Stomach- Partially filled.

Heart-Congestion of heart musculature

Liver- Enlarged with round borders.

Sronchi- Congested.

Longs-Normal no tubercles could be derected.

Abdominal cavity-Filled with serous fluid, ascites and severe peritonins.

Stomach- Partially filled.

Intestines- Congested and yellow stained meseniry.

Kidneys- Almost liquefied with calculi and pus.

Reproductive organs- Ruptured oterus filled with thick caseated mus-

SUMMARY OF LESIONS. Severe lesion in uterus and kidneys, ascnes and severe peritonitis.

OPINION ABOUT CAUSE OF DEATH- Considering necropsy findings, the death of this animal occurred due to severe pyometra leading to peritonitis and systemic failure.

POST MORTEM REPORT

Certified that post - mortem examination was conducted on the body of female Elephant DULARI aged around 60 years, me no : 00065DCAFB (custodian Benny p mathew) on 04-01-2022 murickadi ,Kumali on request by social forestry range peerumade

<u>CLINICAL HISTORY</u>- This animal was apparently healthy and feeding, showed distress on 03-01-2022 and died on 04-01-2022 (09:30 A.M.) not responding to treatment

EXTERNAL FINDINGS- The body of female elephant aged over 60 years, well nourished was seen in lateral recumbency and free from external injuries. There was exudation of mucus tinged greenish fluid from oral cavity. Rigor- mortis passed...Skin and appendages normal, abdomen bloated. Tushes missing. Excessive fat deposits in sc tissue

INTERNAL FINDINGS- On examination of visceral organs, following observations were made.

Oral cavity - Tongue protruding out, cyanotic .All the molar tooth worn out with gums invading.

Stomach - Filled with fodder and grains.

Intestines - Congested, with necrotic patches. Blood vessels and lymph nodes of omentum enlarged .Excessive fat deposits on omental folds.

Heart - Enlarged with thickening of musculature

Liver- Diffuse areas of oedema with roundedborders

Bronchii - Congested

Lungs - Consolidated with reduced functional capacity. However no tubercles could be detected.

Abdominal cavity ---Filled with serous fluid.Ascitis

Kidneys - Swollen

Summary of lesions- Molars worn out ,excessive adiposity, thickening heart musculature lungs consolidated

CPINION ABOUT CAUSE OFDEATH : The death of this animal occurred due to senile lesions leading to multi organ failure
