#### COUNTER AFFIDAVIT FILED ON BEHALF OF RESPONDENT NO.08, MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE

- I, Shanmugam Elamurugannan, S/o Late Appavu Shanmugam aged 45 years, Occ: Govt. services, r/o Bengaluru, do hereby solemnly affirm and state on oath as under: -
- 1. I am working as Assistant Inspector General of Forests, Integrated Regional Office, Vijayawada, Ministry of Environment, Forest and Climate Change, Government of India, duly authorized and competent to swear the present Counter affidavit on behalf of Ministry of Environment, Forest and Climate Change (herein after referred as MoEFCC)-respondent no.08.
- I have gone through the petitioner's affidavit filed in support of above petition and submitted the following facts before Hon'ble Tribunal;
- 3. In reply to various allegations and averments made in the petitioner's affidavit filed in support of above OA, it is respectfully submitted that the 'land' is a subject matter of State Government.

The forest areas and the legal boundaries thereof are determined and maintained by the concerned State Government. That, inter alia, being the repository of land records, State Government has the primary responsibility to determine status of any parcel of land, giving due regards to gazette notifications, provisions under State and Central Acts and concerned judgments and directions of the Hon'ble Supreme Court.

- It is respectfully submitted that, to provide for the conservation of forests and for matters connected therewith or ancillary or incidental thereto, the Parliament in the Thirty-First Year of the Republic of India enacted the Forest(Conservation) Act, 1980 ("FC Act", for short). FC Act came into force on 25th October, 1980.
- 5. It is submitted that section 2 of the Forest (Conservation) Act, 1980 ('FC Act', for short) provides that;

"Notwithstanding anything contained in any other law for the time being in force in a State, no State Government or other authority shall make, except with the prior approval of the Central Government, any order directing-

i. that any reserved forest (within the meaning of the expression "reserved forest" in any law for the time being in force in that State) or any portion thereof, shall cease to be reserved;

ii. that any forest land or any portion thereof may be used for any non-forest purpose;

iii. that any forest land or any portion thereof may be assigned by way of lease or otherwise to any private person or to any authority, corporation, agency or any other organisation not owned managed or controlled by Government;

iv. that any forest land or any portion thereof may be cleared of trees which have grown naturally in that land or portion, for the purpose of using it for reforestation.

- It is submitted that the Hon'ble Supreme Court vide interim order dated 12.12.1996 in W.P.No.202/1995 has issued explicit directions for cessation of all non-forestry activities going on in forest area without prior approval of Central Government. The Apex Court vide order referred to above has stated that the word "Forest" must be understood according to its dictionary meaning and also the term 'forest land' occurring in Section '2' of Forest (Conservation) Act, 1980 will not only include 'forest' as understood in the dictionary sense, but also any area recorded as forest in the Government records irrespective of ownership or classification thereof.
- 7. It is respectfully submitted that, the answering respondent vide letter dated. F.No.FC/IRO-VIJ/FCA/NGT/55-03/2021/96 dated 03<sup>rd</sup> December 2021 has requested the PCCF, Andhra Pradesh to furnish the factual status as of now, on the ownership & possession and legal status of the land under question in this instant matter (i.e. Sy No 506-B, 507 situated at Nandyalampet Village, S,Mydukar Mandal, over an extent of 304.Acres), to be furnished on or before 05.12.2021. Copy of the letter dated F.No. FC/IRO-VIJ/FCA/NGT/55-03/2021/96 dated 3<sup>rd</sup> December 2021 is placed as **Annexure-R1**.
- **8.** It is respectfully submitted that, the PCCF, HoFF, Andhra Pradesh vide letter No. EFS02-22021/2020-WLR-2 dated 14.12.2021, submitted the following documents;
  - a. Counter Affidavit filed by the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, Guntur in National Green Tribunal (SZ), Chennai in this case.
  - b. Joint Survey and inspection report dated:12.05.2021 of the Forest and Revenue Departments in Sy.no.506 B & 506 of Nandyalampet Village of Mydukur Mandal of YSR Kadapa District received from the Divisional Forest Officer, Proddatur (WL) Division.
  - c. Joint Survey and inspection report dated:07.08.2021 of the Forest, Revenue and Survey Departments in Sy.no.506 B & 506 of Nandyalampet Village of Mydukur Mandal of YSR Kadapa District received from the Divisional Forest Officer, Proddatur (WL) Division. Copy of the letter No. EFS02-22021/2020-WLR-2 dated 14.12.2021 along with the



documents submitted by the PCCF, Andhra Pradesh is placed as Annexure-RII.

- 9. It is respectfully submitted that, after scrutiny of the documents submitted by the PCCF, HoFF, Andhra Pradesh, it reveals that, the legal status of the area under question i.e Sy.no.506 B & 507 of Nandyalampet Village of Mydukur Mandal of YSR Kadapa District is reported / recorded differently i.e. as "Forest" in RSR and "Reserved Forest" as per Adangal downloaded from Meebhomi Portal of AP and as per the Forest Department records the area in question are "not part of any Notified "Reserve Forest" and also not part of Lankamalla Reserve Forest or Part of Tiger Corridor";
- 10. It is respectfully submitted that, for the purpose of clarity, the Integrated Regional Office, MoEF&CC, Vijayawada vide letter IRO/VIJ/FCA/NGT/55-03/2021/107 dated 21.12.2021 requested the PCCF, HoFF Andhra Pradesh to clarify whether the land under question is a deemed forest as per the order, dated 12.12.1996 of the Hon'ble Supreme court in the WP(Civil) No.202/1995 in the matter of T.N.Godavarman Thirumalpad vs Union of India Copy of the letter F.No. IRO/VIJ/FCA/NGT/55-03/2021/107 dated 21.12.2021 is placed as Annexure-RIII.
- 11. It is respectfully submitted that, the PCCF, HoFF, Andhra Pradesh vide letter No. EFS02-22021/3/2020-WLR-2 dated 26.12.2021 informed that the land in question i.e Sy.no.506 B & 507 of Nandyalampet Village which is classified as "Forest" as per RSR of Nandyalampet Village of Mydukur Mandal of YSR Kadapa District and reported that as per the order of the Hon'ble Supreme court of India dated 12.12.1996 in the WP(Civil) No.202/1995 in the matter of T.N.Godavarman Thirumalpad vs Union of India, attracts the provisions of Forest (Conservation) Act, 1980 even though, it is not a notified forest under the State Forest Act. Copy of the letter letter No. EFS02-22021/3/2020-WLR-2 dated 26.12.2021 is placed as **Annexure-RIV**.
- 12. It is respectfully submitted that, for the purpose of further clarity, the Integrated Regional Office, MoEF&CC, Vijayawada vide letter No. IRO/VIJ/FCA/NGT/55-03/2021/112 dated



30.12.2021 requested the Andhra Pradesh State Government to submit detailed report on the following;

- a. Whether or not the State Government authority issued any such order(s) to the person/ organization etc to allow them to utilize area in question (i.e Sy.no.506 B & 507 of Nandyalampet Village of Mydukur Mandal of YSR Kadapa District) for non- forestry activities without obtaining prior approval of competent authority under FCA, 1980. If any, detailed report may please be submitted along with supporting documents;
- b. The comments of the State Government made under the subject court case may also be furnished;

Copy of the letter dated F.No.IRO/VIJ/FCA/NGT/55-03/2021/112 dated 30.12.2021 is placed as **Annexure-RV** 

- 13. This respondent reserve their right to file additional Counter affidavit as and when it deems fit and necessary during the pendency of the subject case.
- 14. For the reasons stated above and other grounds that are to be urged at the time of hearing of the subject case, this Hon'ble Tribunal may be pleased to pass such other or further orders as this Hon'ble Tribunal may deems fit and proper.



- 1. It is submitted that, I am working as Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh and I am the 3<sup>rd</sup>Respondent herein and as such I am well acquainted with the facts of the case and I am filing this counter affidavit on behalf of respondent 2<sup>nd</sup>also. I have perused the affidavit filed by the applicant and I deny all the allegations made therein except those that are specifically admitted hereunder.
- 2. It is further submitted that, the lands in Survey no. 506-B and 507 situated at Nandyalampet village are classified as Forests as per RSR of Nandyalampet Village, Mydukur Mandal. As per adangal downloaded from Meebhoomi portal, the above lands are shown as Reserve Forest. These are not notified forests. These survey numbers are not part of notified Reserve Forest in Nagasanipalli Beat of Proddatur Range, Proddatur (WL) Division and hence they are not under the control of Forest Department for its protection and conservation. (Enclosed copy of adangal downloaded from Meebhoomi portal and RSR for Survey no. 506-B and 507 of Nandyalampet Village (Annexure I & II).
- 3. It is submitted that the lands in question are under the control of Revenue Department, which have to initiate necessary remedial measures.
- 4. It is further submitted that, the Survey no.506-B and 507 of Nandyalampet Village do not fall under notified forest lands. A joint survey by Forest, Revenue and Survey & Land Records is proposed to be taken up to assess the status as these lands are adjacent to Lankamalla Reserve Forest notified under Section 16 of Madras Forest Act 1882 (Annexure-III) and Machupalli Forest Block under Section 4 of A.P.Forest Act 1967 (Annexure-IV).

I therefore pray that this Hon'ble Tribunal may be pleased to dismiss the above application as the same is devoid of merits and pass such other orders as deemed fit in the interest of justice.

It is submitted that, vide reference 1<sup>st</sup> cited, the Conservator of Forests Kurnool Circle, Kurnool requested to furnish report on joint survey to be conducted by the Forest Department with the officials of Revenue and Survey & Land Records in respect of Sy. No. 506 – B and 507 situated in Nandyalampet Village, Mydukur Mandal of YSR Kadapa District in connection with the O.A. No. 195/ 2020, Dt. 12-10-2020 filed by Sri Putta Sudhakar Yadav, Ex-Chairman, TTD Board, Mydukur of Kadapa District before the Hon'ble National Green Tribunal Southern Zone, Chennai.

In this regard, it is submitted that, the Forest Range Officer, Proddatur, Forest Section Officer, Khajipet Section of Proddatur Range along with the Tahsildar, Mydukur Mandal, Surveyor, Mydukur Mandal and Village Surveyor, Nandyalampet Village, Mydukur Mandal attended the joint survey and inspection on 12/05/2021 and submitted the report of joint inspection through the reference 2<sup>nd</sup> cited.

As per the joint survey and inspection report the following observations are made.

- Sy. No. 506-B extent 38.94 acres and 507 extent 267.56 acres of Nandyalampet Village, Mydukur Mandal, YSR District are classified as "Forest" as per RSR of Nandyalampet Village records pertaining to Revenue Department.
- 2) As per adangal from Meebhoomi Portal of AP the Sy. No. 506-B extent 38.94 acres and 507 extent 267.56 acres of Nandyalampet Village, Mydukur Mandal are classified as "Reserve Forest".
- 3) Sy. No. 506-B extent 38.94 acres and 507 extent 267.56 acres of Nandyalampet Village, Mydukur Mandal, YSR District are not part of any notified forest in Proddatur (WL) Division.
- 4) The alleged area in O. A. No. 195 of 2020 Dt. 12/10/2020 filed by Sri Putta Sudhakar Yadav, Ex-Chairman, TTD Board, Mydukur of Kadapa District before the Hon'ble National Green Tribunal (Southern Zone), Chennai falls in Sy. No. 507 of Nandyalampet Village, Mydukur Mandal.
- The alleged area is about 6.83 acres and falls in Sy. No. 507 of Nandyalampet Village, Mydukur Mandal, YSR District.

# Joint survey and inspection report of the Forests and Revenue Departments in Sy. No. 506 -B and 507 of Nandyalampet Village of Mydukur Mandal, YSR District on 12-05-2021

Today i.e. on 12-05-2021 the officers from Forest Department of Proddatur (WL) Division and Revenue Department of Mydukur Mandal, inspected the Sy. No. 506 - B and 507 of Nandyalampet Village, Mydukur Mandal, YSR District.

The team also inspected the alleged land in O. A. No. 195 of 2020 Dt. 12/10/2020 filed by Sri Putta Sudhakar Yadav, Ex-Chairman, TTD Board, Mydukur of Kadapa District before the Hon'ble National Green Tribunal (Southern Zone), Chennai regarding encroachments to an extent of 304.00 acres in Sy. No. 506-B and 507 of Nandyalampet Village, Mydukur Mandal, YSR District.

During the survey, the following observations are noticed




