RULES

The Goa Restrictions on Transfer of Agricultural Land Rules, 2023

In exercise of the powers conferred by section 12 of the Goa Restrictions on Transfer of Agricultural Land Act, 2023 (Goa Act 18 of 2023), the Government of Goa hereby makes the following rules, namely:—

1. Short title and commencement.— (1) These rules may be called the Goa Restrictions on Transfer of Agricultural Land Rules, 2023.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. *Definitions.*— (1) In these rules, unless the context otherwise requires,—

(a) "Act" means the Goa Restrictions on Transfer of Agricultural Land Act, 2023 (Goa Act No. 18 of 2023);

(b) "Form" means a form appended to these rules;

(c) "period of cultivation" means a period certified by the Mamlatdar as a period during which agricultural land was under cultivation; (d) "Plan" as referred to in section 2 (c), means the Regional plan as in force under the Goa Town and Country Planning Act, 1974 (Act 21 of 1975) on the date of commencement of the Goa Restrictions on Transfer of Agricultural Land Act, 2023 (Goa Act No. 18 of 2023);

(e) "section" means a section of the Act;

(f) "Talathi" means a person appointed as Talathi by the Government;

(g) "transferor" means a person who intends to transfer his agricultural land;

(h) "transferee" means an individual or Industrial or Commercial undertaking or Co-operative farming society referred to in section 3 (1) (a), (b) and (c) of the Act who intends to purchase the agricultural land for carrying out agriculture;

(*i*) "Zonal Agricultural Officer" means a person appointed as Zonal Agricultural Officer by the Government.

(2) Words and expressions used but not defined in these rules shall have the same meanings assigned to them in the Act.

3. Production of documents.— (1) Agriculturist who intends to purchase/ /acquire agricultural land shall produce before the Registering Authority, Krishi Card or a Certificate issued by the Mamlatdar, or by authorized competent authority of any State Government, or such other document showing that he or she is an agriculturist.

(2) Any person who cultivates agricultural land in the State of Goa may make an application to the concerned Mamlatdar for a certificate that he is an agriculturist. The Mamlatdar may conduct such local inquiry as deemed fit by him and issue him such certificate.

(3) The Mamlatdar shall on an application made to him by an applicant or on a reference made to him by the Registering authority, about the nature of land, shall after conducting such local inquiry as deemed fit by him, issue a certificate certifying the nature of land which shall be binding.

4. Cultivation of agricultural land permitted under section 3.— (1) The transferee on acquisition of agricultural land shall take up agriculture on such land within a period of three years from the date of acquisition of such land and continue to carry thereon agriculture, failing which, such land shall vest in the Government, upon expiry of said period of three years or from the date of abandonment or discontinuation of agriculture.

(2) The Collector may on an application made by an individual grant permission to transfer agricultural land to his legal heirs/ /successors during his life time.

5. Procedure to be followed by the Collector under section 3.- (1) The transferor or transferee shall jointly apply to the District Collector in Form I hereto alongwith the following documents:—

(*i*) An Affidavit stating that he shall take up agriculture on agricultural land within a period of three years from the date of acquisition of such land and continue to carry thereon agriculture.

(*ii*) All other documents mentioned in Form I hereto.

6. Scrutiny of application by the Collector.— (1) Upon receiving an application in Form I hereto the Collector shall scrutinize

such application and if he finds the same incomplete, shall intimate to the applicant within seven days directing him to comply with the observations raised by the Collector within 30 days.

(2) The decision to forward the application or reject the same will be taken within seven days of filling of application complete in all respects.

(3) In the event the applicant complies with the observations, the Collector shall after considering Report of the Mamlatdar in Form II decide the application. If the applicant fails to comply with the observations, the Collector shall reject the application.

7. Procedure for conducting inquiry.— (1) The Collector shall forward the application complete in all respects alongwith documents to the Mamlatdar for conducting inquiry.

(2) The Mamlatdar upon receipt of the application shall examine the same and conduct a joint inspection alongwith the Talathi, the Zonal Agricultural Officer or his representative and the applicant, within seven days from the date of receipt of application.

(3) The Mamlatdar shall give his report in Form II hereto to the Collector.

(4) The report of such joint inspection in Form II hereto shall be forwarded to the Collector within seven days of such inspection and shall bear signatures of the Mamlatdar and the Zonal Agricultural Officer.

8. Grant of permission by the Collector.— (1) Upon receipt of report in Form II hereto, the Collector shall examine the report and grant permission in Form III hereto or refuse to grant permission with reasons therefor within a period of thirty days from the date of receipt of the report.

(2) The Collector shall keep record of all such applications received, permissions granted and applications rejected.

(3) The Collector shall send copy of all such permission granted in Form III hereto and

copy of applications rejected in Form IV here to the Taluka Mamlatdar. The Mamlatdar shall make an entry in the remark column of the Form No. I & XIV that "Land is agricultural land and the permission is granted under the Goa Restrictions on Transfer of Agricultural Land Act, 2023 and rules framed thereunder" and all permissions so granted will be recorded in the register maintained by the office of the Mamlatdar.

(4) Sub-Registrar shall send copy of every transfer of agricultural land made under the Act and the rules framed thereunder to the Taluka Mamlatdar who shall record it in the register so maintained.

(5) The Mamlatdar or the official designated by the Mamlatdar shall carry out inspection of such land wherein permission has been granted once in every six months and if any contraventions of the said Act and rules are noticed including failure to take up agriculture within the required time or continue to carry the same, the Mamlatdar shall issue notice to concerned parties and prepare report in presence of witnesses and submit to the Collector, who shall proceed as required under the Act.

9. Recovery of penalty under section 5.— (1) The penalty under section 5 shall be paid by the transferor and the transferee before the Collector in lumpsum or in two equal installments.

(2) If the transferor as well as transferee makes a default in the payment of the whole or part of the penalty, the Collector shall refer the matter to the Mamlatdar concerned and the Mamlatdar shall proceed to recover the sum which is in arrears on the date of order together with any interest due as arrears of land revenue.

10. Procedure to be followed by the Collector under section 6 after forfeiture.— (1) When the Collector declares that any transfer is in contravention of section 3 of the Act, direct the Mamlatdar to forfeit the land in favour of the Government and the possession of land shall be taken over by the Mamlatdar concern within a period of 60 days from the passing of order by the Collector.

(2) The Collector after taking possession of the land shall direct the land so forfeited to dispose by public auction only to the agriculturist.

(3) The cost incurred by the Collector for removal of any impediment on the land while taking possession of the same shall be recoverable as an arrears of land revenue from the transferee.

The Government of Goa is hereby pleased to formulate Goa State Shack Policy for Erection of Temporary Seasonal Structures, Beach Shacks, Deck Beds/Umbrellas, for Tourist Seasons 2023-26 and the same is published herewith for information of general public.

Goa State Shack Policy for erection of temporary seasonal structures, beach shack deck beds/umbrellas, for tourist Seasons 2023-26 (3 years)

1. Introduction .- The State of Goa is located on the west coast of India and is bounded by the State of Maharashtra to the North, and by Karnataka to the East and South, while the Arabian Sea forms Goas Western coast. Goa is India's smallest State in terms of area and the fourth smallest in terms of population. Goa is a tiny emeralds land with its natural scenic beauty, attractive beaches temples and churches, famous for its architecture, feast and festivals and hospitable people with a rich culture. It is also attributed a land with its exquisite mix of sun, surf, and beaches. Ergo, Goa has become one of the preferred family destinations.

Goa encompasses an area of 3,702 km2 (1,429 sq. mi.). Goa features a tropical monsoon climate and being in the torrid zone and near the Arabian Sea, has a hot and humid climate for most of the year. The month of May is usually the hottest coupled with high humidity.

Panaji (Panjim) is the State's capital of Goa, Vasco Da Gama (Vasco) the largest city, while the historic city of Margao still exhibits the influence of Portuguese culture in Goa. The Portuguese colony existed for about 450 years, until it was taken over by India in 1961.

Tourism is a staple industry in the State of Goa which contributes significantly to the economy and generates employment avenues. As a result, major population of the State is directly or indirectly depend on this industry to earn livelihood.

2. Background.— Goa has over 105 kms. of coastal belt with each beach having its own unique characteristic and accomplished it niche across the globe as a land of beaches. Most of the tourism in Goa is concentrated in the coastal stretches and majority of tourists visiting the State frequent to these areas which has influenced commercial activities in these regions immensely.

Government of Goa is the only State in the country which issues permission to the person of Goan domiciles to erect beach shack using eco friendly materials on the nominated beach stretches. This concept of shacks has contributed significantly to entice tourists to the coastal region and thrive tourism in the State. In the initial States of tourism in Goa, beach shacks became popular due to their small numbers, economical rates and simple decor. Over elapsed of several decades, the concept has demonstrated immense improvisation understanding the need of diverse segment tourists and provides them maximum amenities.

Over the period a lot of amendments have been introduced by the State Government in allotment of shacks on the Government beach arena to provide more comfort and benefits to the shack allottees as well as encourage healthy competition among them. As part of these endeavours, Government of Goa through the Department of Tourism has issued guidelines for regulations of the shacks on the beaches which also provide window for compliance of various policies/guidelines of the line departments, besides, compliances of decision of the judiciary issued time to time.

State Government had formulated 3 years Tourism Shack Policy for tourist seasons 2019-22 for erection of temporary seasonal structures, beach shacks/deck-beds/umbrellas/ huts and other structures. However, in the year 2019, Covid pandemic strikes which impacted all the industries owing to various restriction imposed by the authorities to contain the spread to the contagious virus. The shack allottees under the said policy also witnessed immense financial losses due to restrictions on movement of tourists both domestic and internationals. Tourism Shack Policy 2019-22 culminated on 31-05-2022. However, understanding the impact of the pandemic and on the representation received from the Shack Owners Welfare Society, Government of Goa extended Tourism Shack Policy for the tourist season 2022-23 with some modified terms and conditions. The extended policy has also culminated on 31-05-2023 and therefore now this policy by name "Goa State shack Policy for erection of temporary seasonal structures, beach shack deck beds/ umbrellas, for tourist seasons 2023-26 (3 Years)" to provide for regulation and control of shacks erected on identified public beach stretches has been introduced.

3. *Definitions.*— a) Beach Shack: Temporary structures erected on the identified public beach stretches after abiding by terms and conditions of this policy. b) "DOT" or "the Authority": Department of Tourism, Government of Goa.

c) "GCZMA": Goa Coastal Zone Management Authority.

d) "PCB": Goa Pollution Control Board or Central Pollution Control Board, as the case may be.

e) "MOEF": Ministry of Environment, Forest and Climate Change, Government of India.

f)"Identified Public Beach Stretches": Locations identified for the purposes of erection of temporary beach shacks and placement of deck beds, umbrellas, table and chairs, sofa sets and as specified in Appendix-1.

g) "Tourist season": The period between 1st September to 31st May.

h) "Off season": The period between 1st June to 31st August.

i) "Allottee/Licensee": Any applicant who has been successfully allotted dedicated space on identified public beach stretches for erection of temporary shacks.

j) "Family": Family consist of the husband, wife, and unmarried children.

k) "Provisional License": The license issued to the successful shack allottee at the time of demarcation of the beach shack site at the identified public beach stretch to facilitate to obtain all the required statutory permissions.

 "License": The license issued to the successful shack allottee after obtaining all the required statutory permissions and after complying the terms and conditions of this policy. 4. *Purpose of the Policy*.—Licenses shall be granted for:

1) Erection of temporary shacks at the identified public beach stretches as per Appendix 1.

2) Placement of deck beds, umbrellas, table, chairs and sofa sets on the identified public beach stretches

3) Number of beach shacks to be permitted at the identified beach stretches shall be subject to the approval/recommendation of the Goa State Pollution Control Board, Goa Coastal Zone Management Authority or any other competent authorities.

5. Tenure of the License.-

5.1. For beach shacks and deck beds:-

(a) The License issued pursuant to this policy shall be valid one tourist season 2023-24 and further renewable for Tourist seasons 2024-25 and 2025-26 respectively.

b) In case of adverse weather conditions, beach protection, or other public interest activities, the DOT reserves the authority to withdraw the permission granted for shack license and/or deck-beds prior to the specified date and shack allottee will not be entitled to any form of compensation.

6. Erection and dismantling of the shacks and deck beds.—

6.1. For beach shacks:----

a) In accordance with CRZ notification 2011 and including any amendments thereof, the Authority shall allow erection of beach shacks during the tourist season.

b) All beach shacks shall stop their operations by 31st May and the Allottee shall

remove the structures by 10th June, disconnect utilities, and leave the allotted beach shack site clean.

6.2. For deck beds:-

 a) The license shall be issued to place deckbeds, umbrellas, tables, sofa sets, chairs, for the tourist season within demarcated area to be picket fenced by the licensee only.

b) All such deck beds, umbrellas, tables, sofa sets and chairs shall be removed immediately after the end of a particular tourist season.

7. Size and structure of the beach shacks.—

7.1. The maximum size of the beach shacks ("permissible size") shall be maintained at 18 m. (length) x 8 m. (breadth) x 5.5 m. (height), except for-first four beach shacks at Saunta Vaddo beach stretch, which shall be a maximum of 12 m. (length) x 8 m. (breadth) x 5.5 m. (height) only.

7.2. The Allottee shall adhere to the following conditions related to size of the shacks:

a) The size of the beach shack shall be the actual construction i.e. the covered area on the ground and be measured from the poles erected at the four corners of the beach shack.

b) No shack shall be permitted to have a mezzanine floor or an additional floor.

c) Maximum roof extension of one meter from the plinth on lateral sides and two meters in front side will be allowed. However, there shall be no roof extensions from the rear side of the beach shack. 7.3. DOT reserves the right of reducing permissible beach shack size to suitably adapt to the existing site conditions depending on the identified public beach width, public access, site condition/availability of space and other factors.

7.4. The beach shack shall be erected by adhering to the guidelines issued by various statutory authorities such as GCZMA, MOEF, PCB, and other statutory authorities. The beach shack shall be erected out of ecofriendly materials like bamboos/wooden poles with thatched palm leaves/thatched bamboo mat roofing as far as possible. However, in case of paucity of wood the same may be erected out of the other modern materials like steel, synthetic, nylon fabric, etc., for the purpose of frame work due to unpredictable weather conditions. Use of concrete material is absolutely banned. Grouting, plastering, lying of PCC/RCC on the floor/structure/ digging of soak pits/digging and lying of pipes/metal staircases grouted in cement etc., shall not be permitted at any cost as per the guidelines issued by the GCZMA.

8. Permissible Activities under this Policy.—

8.1. For Beach Shacks:— a) Beach Shacks shall undertake sale of cooked food items and beverages only to the visitors.

b) The Licensee shall ensure that the beach shack menu contains freshly cooked Goan cuisine.

c) The Licensee is neither allowed to sell or serve any beverages in glass bottles to the customers outside the demarcated shack area and picket fence area nor the licensee shall allow the customer to carry the glass bottles outside the demarcated shack area.

d) The beach shack allottee shall not sublet the beach shack under any circumstances.

e) No foreigners shall be permitted to work in any beach shack even though he/she may have necessary visa for work.

f) Shack allottees are responsible individually and collectively for keeping the beach clean and litter-free adhering to Goa Solid Waste Management Rules and any other existing statutory requirements and to the following conditions:

1. Keep the area surrounding the beach shack clean all the times and strict adherence to the Goa Solid Waste Management Rules for proper garbage collection, segregation, and disposal.

2. Beach shack allottee shall ensure scientific disposal of sewage waste including black & grey water with the help of concerned local Panchayat Raj Institutions (PRIs)/ULBs (Urban Local Body).

3. Handover of segregated garbage to the beach cleaning contractor as appointed by DOT and maintain a proper log book with daily entries.

8.2. For Deck Beds:— a) Beach shack allottee shall place deck beds, umbrellas, tables, chairs and sofa set only within 15 meters from the outer boundary of the front of the shack towards the sea or within area as demarcated by DOT which may be curtailed subject to High Tide Line.

9. Eligibility criteria for beach shacks.— a) The beach shacks shall be allotted as provided below:-

i. Category I: 10% of the total beach shacks on the identified public beach stretches shall be allotted to applicants without any prior experience.

ii. Category II: 10% of the total beach shacks located on identified public beach stretches shall be allotted to those applicants having minimum of 01 and maximum 04 years of experience, in the respective District.

iii. Category III: Remaining absolute numbers of beach shacks after allotting to categories I & II above of the total beach shacks, shall be allotted to those applicants having minimum of 05 and above years of experience, in the respective District.

b) The distribution of numbers of beach shacks on the identified public beach stretches among the respective categories subject to the Department of Environment approval.

c) For the purpose of calculating number of beach shacks to be allotted under Category I and II above, if there is any fraction arising while arriving at percentage figure, the benefit of the fraction shall go to higher side only if the fraction is 0.5 and above for the purpose of clarity illustration of distribution of number of beach shacks is as per Appendix 4.

d) Applicant should not have any employment, pension, or shall not be engaged in any business, vocation, profession and any nature of employment directly or indirectly.

e) Only one beach shack shall be permitted per family.

f) Applicant shall not have any pending criminal charge sheets in Indian courts OR convicted in the Court of Law or black isted/ levied penalty for sub lease of beach shack and application received from such applicant shall be summarily rejected.

10. Application Procedure.— a) The application forms will be made available on the website of the Department of Tourism i.e. www.goatourism.gov.in and the form has to be downloaded and submitted to the offices of RFC's during working hours. No physical forms will be made available by the DOT.

b) Applicant must submit a completed application form (Appendix-3), for relevant category along with required documents and one demand draft towards application form. Applications without the required demand drafts will be summarily rejected.

c) As a proof of experience of beach shacks, the applicant shall enclose:

i. Copies of permissions issued in the past or copy of letter issued by the DOT that he/she was a successful shack allottee. No other documents shall be accepted.

ii. For the purpose of eligibility under this policy, the number of years of experience in the form of Licenses issued in the name of the person who is deceased, shall be counted in case the applicant is the member of the family. iii. Licenses issued by this Department prior to 1998 shall not be considered as a proof of experience in view of the Judgement passed by the Hon'ble High Court.

d) Applicants must submit email address (solely for shack operations) in application form for further communication with the DOT.

11. Selection Procedure.—

A. For Beach Shacks:— 1) Upon receipt of an application, GEL shall scrutinize the forms submitted as per respective experienced categories, new applicants and beach stretch.

2) If the number of eligible applicants is more than the number of beach shacks permitted on any particular identified public beach, the selection shall be decided by a draw of lots.

3) The draw of lots shall be done first for selection of the successful shack allottees and further DOT shall also select wait listed applicant by way of draw of lots as per respective categories per identified public beach stretches.

4) Mutual allocation of beach shacks locations among successful beach shacks allottees shall be permitted/allowed on the respective identified public beach stretch only if consensus is arrived among all the successful shack allottees for the particular identified public beach stretch.

Failure to arrive at a mutual consensus, allocation of beach shacks locations shall be decided by a draw of lots.

5) Any application for mutual swapping of locations of beach shacks for a particular identified public beach stretch shall be submitted to the DOT within a period of 7 working days from the date of draw of lots.

6) The beach shack applicant shall be present in person for the draw of lots.

In case, the applicant fails to remain present for the draw of lots for the selection of beach shack allotment as well as for allotment of beach shack location, the same shall be held in his/her absence. In the case, where the absent applicant becomes successful shack allottee, he or she must visit the DOT within three working days to sign the beach shack location site plan, failing which the allotment of beach shack shall be cancelled forthwith and the same shall be allotted to the next waiting list applicant.

7) The list of successful applicants for successful beach shack allottee shall be uploaded on the website of the DOT mentioned above. Complaints/Objections, if any, against any successful applicant shall be submitted to the DOT.

8) In case, the number of applications received are less than that of the total number of shacks permitted in Category I and/or Category III then the remaining shacks of this category shall be allotted to the category II.

9) In case, the number of applications received are less than that of the total number of shacks permitted in Categories I and II, then the remaining shacks of this category shall be allotted to the Category III.

10) In case, the number of applications received are less than that of the total number of shacks permitted in Categories II and III, then the remaining shacks of this category shall be allotted to the Category I.

11) In case, the number of applications received are less than that of the total number of shacks permitted in Categories II, then the remaining shacks of this category shall be allotted to the Category I.

B. For Deck Beds:— 1) Application received for placement of deck beds, umbrellas, tables, chairs, sofa sets shall be summarily rejected in the following instances:

i) Site condition is not feasible,

ii) Causes congestion on the beach,

iii) Affects movement of tourist and the lifeguarding/beach cleaning/tourist police operations.

12. Standard operating requirements and associated penalties.—

a) Shall remit the annual beach shack fees by way of Demand Draft within a period of 10 days from the date of draw of lots.

b) Build shack within a month after physical demarcation of the beach shack location site by DOT. No construction shall be permitted without obtaining a provisional license from the DOT.

c) Shall obtain permissions/NOC's/ licenses as required from all other concerned Departments for operation of the beach shack within a period of two months, after physical demarcation, failing to do so, the allotment of shack will be cancelled.

d) Construct beach shack as per the specifications and provisions stipulated at Clause (7) above, only at the allotted location indicated as per DOT beach shacksdemarcated site plan and shown to the allottee. The shack allottee must sign site plan copy for official records of the DOT.

e) Either beach shack licensee or identified manager could only manage the beach shack.

f) Shall mandatorily install CCTV system adhering to the following conditions:

i. CCTV cameras shall be functional throughout the operational hours of the shack.

ii. CCTV cameras shall record the beach shack area including its interiors and the surrounding area and shall give real-time footages of the videos recorded with internal looping and non-invasive characteristics. The licensee shall maintain 30-days footage at all times.

iii. DOT reserves the right to verify the working condition of such installed CCTV cameras.

iv. CCTV footage/recording can be viewed by the officials of DOT as and when required and the footage or recording shall be provided as and when required. b) Beach shack operators to track, address, complaints about activities of illegal hawkers, garbage dumps on the shores, medical emergencies and other violations reported through Beach Vigilance App, Help Line No. 1364 or any other mode.

c) In case of any emergency, beach shack operators are suggested to coordinate with the lifeguards, tourist police immediately to take necessary actions.

12.2 Upon Commencement of the beach shack operations:— a) Timing for operation of Beach Shack shall be from 7.00 a.m. to 11.00 p.m.

b) Shall use dedicated Bank Account for purpose of beach shack related transactions, details of which shall be submitted to DOT in the application form and the same shall be linked with POS machine.

c) Display requirements:— i. Shall display a Board of standard size of 3 mtr. X 2 mtr. as prescribed at Appendix-5 at conspicuous area at the entrance of the shack.

ii. Shall display board with Help Line No. 1364 in the beach shack as well as in the picket fencing area.

d) Personnel requirements within the beach shack:— i. The beach shack allottee shall submit the list of each staff engaged/working in his/her beach shack along with police verification report.

ii. Shall provide uniform to its staff working in the beach shack. Any person operating or working within or for the shack without wearing uniform and a valid ID issued by the DOT shall be presumed unauthorized.

iii. The beach shack allottee shall obtain identity cards from the DOT.

a) To obtain a digital copy of identity card (s) on same day, the license needs to apply on DOT Portal. The Licensee needs to provide required information of all the working employee(s) to DOT through the portal. DOT shall charge Rs.100.00 for obtaining physical copy. (PVC material). b) In case of the employee being replaced and licensee is recruiting an employee, shall apply for new identity card within a week with same details of new employee.

c) All working employees including manager need to keep physical copy identity card during the inspection.

d) Identity card is non transferrable.

e) Customer Service Requirements:----

i. Government of Goa is in line with Digital India likely to introduce "Digital Coast" at beaches of Goa where shack allottees shall compulsorily provide POS machine with his/ her preferred bank which needs to be used for all digital transactions.

ii. Shall provide printed bills with GST number for sale of food and beverages. The price of all the items shall be displayed for information of the customers and it is ensured that customers are charged at such rates only.

iii. Shall provide UPI payment system through online and prominently displayed in the beach shack, linked to POS machine as mentioned above, for accepting all sort of shack related payments. Beach shack allottee shall use his/her own bank account of whose details are provided in the application form, for all sort of shack related transactions and the said QR code facilities.

iv. Shall submit bank account statement to the DOT by Email every 3 months or as and when requisitioned by the DOT.

f) Environment protection requirements:----

i. Shall compulsorily provide portable toilet facility adhering to the norms of Goa Pollution Control Board, GCZMA and other statutory authorities.

ii. For playing of music in beach shacks, the beach shack allottees shall follow the norms as per the Noise Pollution (Regulation and Control) Rules, 2000 of Central Pollution Control Board. The sound of the music played shall be heard only within the shack and shall not cause any disturbance to surrounding occupants. iii. Shall make provision for giving Fire cover and First Aid to the structure and the public/tourists and shall contact the Office of the Fire Service to obtain guidelines.

12.3 Upon allotment and operations of deck beds:— 1) The deck-beds shall be painted indicating licence number for the beach shack allotted.

2) Placement of deck beds, tables, chairs, umbrellas, and sofa sets within 15 mtrs. subject to High Tide Line from the frontage of the shack area which shall be picket fenced. The licensee shall ensure that no free movement of tourists/general public shall be hindered.

12.4 Additional conditions for shacks permitted at beaches identified as turtle nesting sites:— a) The shack allottee shall play proactive role in informing any of the incidences of nesting, and shall actively cooperate with the forest staff, in protection of turtle, turtle nesting site, turtle eggs hatching etc.

b) The shack allottee shall not allow the following after sunset and sunrise (i.e., after 6.00 p.m. till the sunrise on the next day).

i) Operation of beach shack & related activities like placing of deck beds. No beach beds shall be set up in the intertidal zone or very close to the waterline, which affects the turtle's movement.

ii) Artificial lighting: The shack allottee shall desist from installing any outdoor illumination. The indoor lighting should also be muted and provided with opaque shields on sea facing side.

iii) Playing of loud music in the Beachshacks beyond 06.00 p.m. and holding of beach parties shall be prohibited.

iv) Display of fireworks as these can have adverse effect on the turtles nesting.

c) Shall be liable to pay compensation of Rs. 1.00 lakh for each violation. In case, the amount of compensation is not paid by the delinquent/s, the same shall be recovered as arrears of land revenue.

12.5 Activities Prohibited under this Policy:—

A. For beach shacks:— a) Erection of beach shack at the site other than indicated in the license issued by the DOT under this policy and as demarcated on the site plan and shown to the beach shack allottee.

b) Installing/placing standees, Display Board or any nature of installation outside the shack or on top of the shack.

c) Shack allottee shall not ply or drive any vehicles in the beach area.

d) The beach shack allottee shall not be sublet under any circumstances. The beach shacks allottee are subject to surprise inspections by DOT and in case it is found that the allottee or Manager is absent during three consecutive inspections, it shall be presumed that the shack has been sublet. In case of subletting confirmed with/without documentary evidences to the satisfaction of DOT, penalties shall be levied as per Clause 20.

B. For placement of deck beds, tables, chairs, umbrellas, sofa sets, etc.:— a) Illegal placement of deck beds, tables, chairs, umbrellas, tents, sofa sets etc. without valid permission.

b) Shall not place deck beds, chairs, tables, umbrellas, etc., so permitted beyond 15 m. (Subject to high tide line) from frontage of the shack area or along the side of the shacks, plot boundary of applicant towards seaward side or area demarcated by DOT from the outer boundary of the owners so eligible under this policy.

c) Discharge of dirty water, liquid, sewage from the toilets, wash basin or cleaning area, garbage or any dry waste on the beach, or into the sand.

d) No septic tanks soak pits nor open draining of toilet waste in the ground.

Sinking of bore well, etc., in and around the Beach Shack area (as per Goa Ground Water Regulation Act, 2022, and Rules, 2003) shall not be permitted at any cost.

e) Any deck beds, tables, chairs, umbrellas, sofa sets, found without permission/permission number painted on it shall be treated as unauthorized deck bed and the same shall be seized and confiscated/dismantled by using chain saw/cutter, on the spot.

f) Any unauthorized deck bed, umbrella, tables, chairs, sofa set, etc., shall be treated as nuisance as defined under Goa Tourist Places (Protection and Maintenance) Act, 2001 and the violator shall be prosecuted under section 10 of the above Act 2001. Any complaint arising out of the above said placement shall be resolved by the Director of Tourism and his decision in this regard shall be final.

C. Other General Conditions:— a) Do not disrupt sand dunes or their vegetation. Any violation shall lead to CRZ Notification, 1991 violation by Shack allottee and responsible for strict legal action.

b) Rules made under "The Goa Tourist Places (Protection and Maintenance) Act, 2001" and "The Goa, Daman and Diu Registration of Tourist Trade Act, 1982 (Act 10 of 1982) shall be strictly adhered by the shack allottee.

13. Fees for erection of beach shacks at the identified beach stretches.— 1. The cost for application form shall be Rs. 10,000.00 (Rupees ten thousand only (non-refundable) payable at the time of submission of application forms which will be one time fee.

2. Application processing fee of Rs. 13,000.00 (Rupees thirteen thousand only) (Non-refundable) payable by the successful shack allottee after draw of lots which will be onetime fee.

3. The year wise fees structure payable/deposited by the successful shack allottee.

4. The fees payable for seeking permissions for placement of deck beds and umbrella or table or chairs in front of shack as specified at clause 8.2 (a) is Rs. 30,000.00 (Rupees thirty thousand only) per season.

5. The successful allottee shall be liable to pay the annual beach shack fees by way of Demand Draft within a period of 10 days from the date of draw of lots, failing which action shall be initiated as per Clause 20.

6. The Security Deposit (Refundable) in the form of Demand Draft payable by the successful applicants shall be submitted along with annual fees of the tourist season 2023-24.

"A" Category beaches: Rs. 1,00,000.00 (Rupees one lakh only)

"B" Category beaches: Rs. 50,000.00 (Rupees fifty thousand only).

7. The demand drafts towards application forms and security deposit shall be drawn in favour of Director of Tourism, Panaji-Goa, payable at Panaji-Goa and Demand Draft towards processing fees shall be drawn in favour of M/s. Goa Electronics Ltd.

8. The annual beach shack fee shall be paid every year latest by 15th August. In case of non-payment of the annual beach shack fee, action shall be taken as per Clause 20.

14. Instructions ro unsuccessful shack applicants.— The un-successful shack applicants shall not erect any beach shack.

15. Instances for allotment of shacks to waiting list applicant.— a) Failure of successful allottee to attend the draw of lots and also in case of failure to report to the DOT within working three days from the date of draw of lots to sign the site plan.

b) Failure to pay the annual beach shack fee within a period of 10 days from the draw of lots for the tourist season 2023-24.

c) Failure to pay the annual beach shack fee on or before 15th August of the tourist season 2024-25 and 2025-26.

d) If beach shack allottee has obtained the shack license under this policy fraudulently.

e) If application has been withdrawn by the successful shack allottee.

f) All instances wherein licenses issued under this policy has been cancelled/ /revoked.

16. Action by successful shack allottee in the instance of forfeiture of security deposit.—

a) In the event, the security deposit stands forfeited for breach of terms and conditions of this policy, the beach shack allottee shall submit a fresh security deposit for equivalent amount within a period of 07 days upon receipt of the intimation of such forfeiture in order to continue the license for erection of temporary beach shack so allotted.

17. Release of security deposit amount.— a) The security deposit will be returned after the end of this policy period and after the removal of structure and report obtained from the Designated Authority appointed by the DOT stating that the structure has been removed and land has been restored to its original form latest by 10th of June of every year for the period of policy.

b) Failure on the part of the applicant to remove the structure latest by 10th of June of every year for the period of license, the security deposit shall be forfeited, and the beach shack shall be removed by the Department and cost of removal shall be recovered as land revenue arrears from the shack allottee.

18. Action taken by DOT in case of death of a successful shack allottee.— In case of death of the successful shack allottee upon request of the member of the family of the deceased person or in their absence a legal heir of the deceased shack allottee, shall be allowed to operate the shack for the remaining period of this policy.

19. Action/Penalties for breach of terms and conditions of this policy.— All the terms and conditions of this policy shall be strictly adhered to and any violation thereto shall cause action as below:
