#### Notification

D.Tpt/EST/3119/2023/27

The following draft rules which the Government of Goa proposes to make in exercise of the powers conferred by sections 28, 38, 65, 95, 96, 107, 111, 138, 159, 176, 211 and 213 of the Motor Vehicles Act, 1988 (Central Act No. 59 of 1988), to further amend the Goa Motor Vehicles Rules, 1991, are hereby pre-published as required by section 212 of the said Act, for information of all the persons likely to be affected thereby and notice is hereby given that the said draft Rules will be taken into consideration by the Government after the expiry of a period of fifteen days from the date of publication of this Notification in the Official Gazette.

All objections and/or suggestions to the said draft Rules may be forwarded to the Director of Transport to the Government of Goa, Junta House, Panaji, dir-tran.goa@nic.in before the expiry of the said period of fifteen days so that they may be taken into consideration at the finalization of the said draft Rules.

#### DRAFT RULES

1. *Short title and commencement.*— (1) These rules may be called the Goa Motor Vehicles (Amendment) Rules, 2023.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. *Amendment of Rule 4.*— In the Goa Motor Vehicles Rules, 1991 (hereinafter referred to as the "Principal Rules") in rule 4, for sub-rule (2), the following sub-rule shall be substituted, namely:—

"(2) The Authorization once granted shall be effective throughout the State. The applicant is required to submit completion certificate of orientation course conducted by an Institution recognized by the Government. The cost of orientation programme shall be borne by the applicant.

PSV Badge holder shall undergo refresher training at the time of renewal of driving licence."

3. *Insertion of new rule 121 A.*— In the Principal Rules, after rule 121, the following rule shall be inserted, namely:—

"121A. *Parking slots at Manohar International Airport.*— Consent from GMR Goa International Airport Ltd., for providing

parking slots/pickup bays at Manohar International Airport at Mopa shall be sufficient for issuance of permits by the Regional Transport Authority.”.

4. *Insertion of new rule 158A.*— In the Principal Rules, after rule 158, the following rule shall be inserted, namely:-

“158A. *Painting and marking of motorcabs.*— Motorcabs attached to Blue cab Prepaid Taxi Service at Manohar

International Airport at Mopa shall be painted in blue colour, as prescribed by the Regional Transport Authority and rest of the body in white colour.”.
