

STATUS REPORT FILED BY THE 7TH RESPONDENT

I, A.Narayana, B.Tech, S/o Rajaiah, aged about 57 years, Working as Executive Engineer, North Tanks Division, I & CAD Department, Budha Bhavan, 3rd floor, Hyderabad do hereby solemnly and sincerely affirm and state as follows:-

1. I state that I am the 7th respondent herein and I am well acquainted with the facts and circumstances of the case and I have been authorized to file this status report on behalf of the 7th respondent.
2. With reference to the Hon'ble NGT orders Dt.03.08.2022 in OA No.163/21 it was directed to the Irrigation Department and District Collector to submit action taken report for delay in the eviction of encroachers and restoration of water bodies to its size and shape.
3. It is humbly submitted that as stated in the affidavit dated 22.03.2022 there are 185 tanks identified within GHMC limits and all the tanks are demarcated with the FTL boundaries and



prepared the FTL boundary maps from the year 2012 and submitted to Lake Protection Committee, HMDA, constituted by the Government of Telangana vide G.O.Ms.No.157 of MA&UD Dept, Dt. 06.04.2010 (Annexure-I) which is the nodal agency for issuing preliminary and final notification of FTL boundary maps in the public domain. The Lake protection committee have issued preliminary notification for 157 tanks on HMDA website and for the remaining 28 lakes preliminary notification have to be issued.

4. It is humbly submitted that about 52 tanks are issued final notification and notified on HMDA website and the remaining tanks are being prepared by concerned Tahsildars for submission to Lake Protection Committee (LPC), HMDA through concerned District Additional Collectors. Once the FTL boundary maps are finalized, the same will be permanent.

5. In this regard, it is respectfully submitted that, there are some existing encroachments within FTL and Buffer zone of lakes prior to demarcation of FTL boundary 2012. Most of the lakes within



GHMC area are partially encroached, some are majorly encroached and some are prone to encroachment. There are 8718 encroached structures within FTL limits and 5343 structures within Buffer zone limits. 51 lakes are free from encroachments and 85% encroachments are identified in 30 lakes and 15% encroachments are identified in 104 lakes. List of the encroachments is annexed herewith(Annexure-II).

6. It is humbly submitted that if any new encroachments are observed within FTL / Buffer zone limits, actions are being initiated in co-ordination with GHMC & Revenue Departments and criminal cases are registered against the encroachers.
7. Further it is humbly submitted that some of the existing encroachments within FTL / Buffer zone are already removed and fenced, due to pending litigations / cases filed by the landlords/ pattadars the remaining encroachments could not be removed thereby the lake protection works are stalled in that area, In such case it is difficult to remove the encroachments.
8. It is also submitted that with regard to the lake boundary protection works, it is respectfully submitted that GHMC has sanctioned funds for Rs. 94.17 Crores for erection of chain link fencing around the 63 number of lakes. The said lake protection fencing works are 70% completed and 30% could not be completed due to pending of cases in various courts.

9. Further it is humbly submitted that even after exercising the preliminary notification of draft FTL boundary maps by calling for objections/ suggestion from the general public, the final notification of FTL boundary maps were issued by the Lake Protection Committee, HMDA. This respondent herein also taken-up the balance lakes protection from the encroachments which are finally notified tanks. The landlords/ pattadars has approached the Hon'ble courts and has obtained status quo thereby this respondent is not able to evict them.

10. In view of the above said facts and pending litigations in various courts is only delaying the lake boundary protection works. This respondent is taking all precautionary steps for lake boundary protection in such locations by deploying Lake Protection Force (LPF) and installed CCTV Cameras to watch and ward the boundary protection. Further it is humbly submitted that once the court cases are disposed this department will take up the process of evicting the encroachers and restore the water bodies to its original shape and size. The list of court cases pending against each water body are enclosed herewith (Annexure-III).

For the reasons stated above, it is humbly prayed that this Hon'ble Tribunal may be pleased to consider the Report and pass appropriate orders to the facts and circumstances of the case and thus render Justice.

ORDER:

In the G.O. 1st read above orders were issued prohibiting polluting industries, major hotels, residential colonies and other establishment that generate pollution in the catchment area of Osmansagar and Himayatsagar Lakes falling in the Villages listed in the annexure to the said G.O.

2. A Writ Petition No.9386/2007 was filed in the Hon'ble High Court for protection of the catchment area and area around Himayatsagar and Osmansagar lakes in tune with G.O.Ms.No.111 MA, dated:08.03.1996.

3. The Hon'ble High Court after detailed arguments in the matter has ordered in the reference second read above, among others, suggesting constitution of Comprehensive regulatory body consisting of representatives of all concerned authorities to protect all the lakes and regulate developments in the catchment area of Himayatsagar and Osmansagar lakes.

4. The Metropolitan Commissioner, Hyderabad Metropolitan Development Authority has submitted his reports on the subject matter in the references third and fourth read above.

5. Government have examined the proposal and keeping in view the reports of the Metropolitan Commissioner, Hyderabad Metropolitan Development Authority and in compliance of the orders of Hon'ble High Court in W.P.No.9386/2007, dated:02.02.2010, have decided to constitute a Lake Protection Committee for preservation and protection Lakes in Hyderabad Metropolitan Development Authority area pending consideration of enactment of separate legislation for constitution of Lake Protection Authority.

6. Government accordingly, hereby constitute the Lake Protection Committee for preservation and protection of Lakes in Hyderabad

7. The committee can co-opt any expert or officer concerned for the effective functioning of the committee.

8. The following are the functions of the Lake Protection Committee:

- i Listing of all lakes along with their FTL in HMDA area
- ii Wide publicity and awareness campaign for protection of the lakes
- iii To prepare action plan for desilting of the lakes and inflow channels and such other measures required for maintenance or cleaning of the inflow channels in to the lakes and issue instructions / guidelines to the concerned agencies for implementation of action plan.
- iv Removal of existing encroachments in the FTL and foreshore areas.
- v To clearly demarcate the lakes upto FTL by raising bunds along FTL and arranging for watch and ward for preventing future encroachments and misuse of the lake environment.
- vi To workout and suggest modalities for regulation and rehabilitation of existing activities/structures in the catchment area of Osmansagar and Himayatsagar lakes.
- vii To do such other things as may be incidental or conducive to the efficient administration for protection and improvement of the lakes and their catchments.
