2. This respondent denies each and every averment made in the affidavit filed

in support of the application as false and incorrect except those that are

specifically admitted herein in this counter affidavit.

3. With regard to the averments made in Paragraph 1 of the affidavit is not

related to this respondent and hence there are no remarks.

4. With regard averments made in Paragraph 2 of the affidavit is denied as

false. It is respectfully submitted that it is a fact that Ministry of

Environment, Forest and Climate Change (MoEF&CC), Govt. of India

issued a Notification on Plastic Waste Management Rules, 2016 vide GSR

820 (E), dated 18.03.2016. It is a fact that the Andhra Pradesh Pollution

Control Board is the prescribed authority for enforcement of provisions of

these rules relating to Registration, manufacture of plastic products and

multi-layered packaging, processing and disposal of plastic waste for the

State of Andhra Pradesh. Instructions were issued from time to time for

implementation of Plastic Waste Management Rules, 2016 as amended

from time to time in all the ULBs.

5. With regard to the averments made in Paragraph 3 of the affidavit is not related to this respondent and hence there are no remarks.

6. With regard averments made in Paragraph 4 of the affidavit is denied as false. It is submitted that it is a fact that as per Rule 9 (3) of PWM Rules, 2016, manufacture and use of non-recyclable multi-layered plastic, if any should be phased out in two years time. As per the information available with the A.P Pollution Control Board, no non-recyclable multi-layered plastic producing units existing in the State of Andhra Pradesh.

7. It is submitted that, instructions were issued to the ULBs to send non-recyclable Plastic Waste to the nearby cement plants as on date 19 ULBs viz., Vijayawada, Gudivada, Dharmavaram, Nandigama, Chirala, Macherla, Nandikotkur, Ananthapuram, Tadipatri, Kadiri, Kadapa, Proddutur, Pulivendula, Jammalamadugu, Badvel, Yerraguntla, Rajampet, Rayachoti & Tirupathi have tied up with nearby Cement Plants and 920MT of non-recyclable plastic waste has been sent to the Cement plants so far.

8. It is submitted that the non-recyclable plastic waste is being used for road construction works in Visakhapatnam, Vijayawada, Tirupathi, Rajamahendravaram, Kakinada & Amalapuram ULBs and 26 MT of Non-recyclable plastic waste is used for construction of roads. Instructions were also issued to 41 ULBs who are within100 KM radios to the Waste to Energy Plants to send combustible dry waste to the Waste to Energy Plants.

PWM Rules, 2016, multi-layered packaging means any material used or to

be used for packaging and having at least one layer of plastic as the main

ingredients in combination with one or more layers of material such as

paper, paper board, polymeric materials, metalized layers or aluminium

foil, either in form of laminate or co-extruded structure.

11. With regard to the averments made in Paragraph 7 of the affidavit is not

related to this respondent and hence there are no remarks.

12. With regard to the averments made in Paragraphs 8 & 9 of the affidavit is

denied as false. It is submitted that as reported by the APPCB, no multi-

layered plastic sachets or pouches or packaging producers existing in

Andhra Pradesh. However, instructions were issued to all the ULBs to

seek assistance of the Producers and such system shall be set up within

one year from the date of final publication of these rules in the Official

Gazette of India.

13. With regard to the averments made in Paragraph 10 to 17 of the affidavit is

not related to this respondent and hence there are no remarks.

14. With regard to the averments made in Paragraph 18 of the affidavit is

denied as false. It is submitted that It is a fact that as per the Rule 9 (1) of

PWM Rules, 2016, the responsibility of producers, importers and brand

15. It is submitted that since, there are no non-recyclable multilayered plastic waste producing units & no multilayered plastic sachets or pouches or packaging producers are existing in the State of Andhra Pradesh as reported by the A.P.Pollution Control Board. If, any Brand Owner & Producer operating without Registration from APPCB they shall take action against the defaulting units as per provisions of PWM Rules, 2016 as amended from time to time. However, instructions were issued to all the ULBs to seek assistance of the Producers and such system shall be set up within one year from the date of final publication of these rules in the Official Gazette of India.

- 16. With regard to the averments made in Paragraphs 19 to 29 of the affidavit is not related to this respondent and hence there are no remarks
- 17. It is submitted that this respondent craves leave of this Hon'ble Tribunal to raise additional counter in the course of proceedings, if required.

In the above circumstances, it is humbly prayed that this Hon'ble Tribunal may be pleased to dismiss the above Original Application No.22 of 2022 and pass such further or other orders as this Hon'ble Tribunal may deem fit and proper in the facts and circumstances of the case and thus render justice.

The attention of the Commissioners of all the Urban Local Bodies in the State is invited to the reference 5th cited, wherein detailed instructions were already issued. In the reference 6th cited, the Government have issued orders constituting State Level Monitoring Committee under the Chairmanship of the Principal Secretary to Govt., MA&UD Department, under Rule-16 of Plastic Waste Management Rules, 2016, for effective monitoring of implementation of the said Rules in the ULBs of the State. It is further informed that Booklets of Plastic Waste Management Rules, 2016 were already communicated to all the Municipal Commissioners vide reference 2nd cited.

- 2. In view of the above, the instructions issued in the reference 5th cited are reiterated:
 - i. In the reference 1st cited, the Ministry of Environment, Forest & Climate Change, GoI, has notified the Plastic Waste Management Rules, 2016 in supersession of Plastic Waste Management (Management & Handling) Rules, 2011 (copy of the rules were already sent to all ULBs), which apply to every plastic waste generators, local bodies, manufacturers, importers and producers and that these Rules stipulated that carry bags made of Vergin or recycled plastic shall not be less than Fifty microns in thickness.
 - ii. The responsibilities of the Local Bodies specified in Rule-5, 6, 15 & 17 of the said Rules are as follows:
 - Rule-5 (b): "Local Bodies shall encourage the use of plastic waste (preferably the plastic waste which cannot be further recycled) for road construction as per Indian Road Congress guidelines or energy recovery or waste to oil, etc. the standards and pollution control norms specified by the prescribed authority for these technologies shall be complied with"

Rule-6:

 Every local body shall be responsible for development and setting up of infrastructure for segregation, collection, storage, transportation, processing and disposal of the plastic waste either on its own or by engaging agencies or producers.

- The local body shall be responsible for setting up, operationalization and coordination of the waste management system and for performing the associated functions, namely:-
- a) ensuring segregation, collection, storage, transportation, processing and disposal of plastic waste;
- b) ensuring that no damage is caused to the environment during this process;
- c) ensuring channelization of recyclable plastic waste fraction to recyclers;
- d) ensuring processing and disposal on non-recyclable fraction of plastic waste in accordance with the guidelines issued by the Central Pollution Control Board;
- e) creating awareness among all stakeholders about their responsibilities;
- f) engaging civil societies or groups working with waste pickers; and
- g) Ensuring that open burning of plastic waste does not take place.
- The local body for setting up of system for plastic waste management shall seek assistance of producers and such system shall be set up within one year from the date of final publication of these rules in the Official Gazette of India.
- 4. The local body to frame bye-laws incorporating the provisions of these rules.
- Rule-12(3): Every local authority for the enforcement of the provision of these rules relating to waste management by waste generator, use of plastic carry bags, plastic sheets or like covers made of plastic sheets and multilayer packages.
- Rule-15(3): The Local Body shall utilize the amount paid by the customers for the carry bags exclusively for the sustainability of the waste management system within their jurisdictions.
- Rule-17(2): Every Local Body shall prepare and submit an annual report in Form-V to the concerned Secretary-in-charge of the Urban Development Department under intimation to the concerned State Pollution Control Board or Pollution Control Committee by 30th June, every year.
- 3. Therefore, the Commissioners of all the Urban Local Bodies in the State are hereby once again directed to go through the Plastic Waste Management Rules, 2016, and implement the above said Rules without fail and furnish their action taken reports with regard to the implementation of the above Rules in the following format through the RDMAs concerned:

The attention of the Municipal Commissioners of the ULBs mentioned in the address entry is invited to the references cited.

- 2. In the reference 4th cited, the Municipal Commissioners were directed to discuss with the managements of the Cement Plants, located around their ULBs, to make suitable arrangements, to tie-up with Cement Plants, for disposal of combustible portion of Dry Waste generated in their ULBs. The Rule 5 of Plastic Waste Management Rules, 2016 states that the ULBs shall encourage the use of Plastic Waste, preferably the Plastic Waste which cannot be further recyclable for road construction or energy recovery etc.,
- 3. Though certain ULBs have reported that they have tied-up with the Cement Plants, there is no considerable progress in disposal of Plastic Waste in the ULBs.
- 4. Therefore, a tie-up arrangement of the ULBs to the Cement Plants is made (attached to this Circular as Annexure), considering the distance. Thus, the Municipal Commissioners mentioned in the address entry are requested to discuss with the Managements of the Cement Plants, to make suitable arrangements for disposal of combustible portion of the Plastic Waste generated in the ULBs. However, if tie-up arrangement is already made in any ULB with the Cement Plants it can be continued and considering the feasibility and other ground situations the Municipal Commissioners can make tie-up arrangements with the nearby Cement Plants.

- 5. The Municipal Commissioners are also directed to make arrangements for suitable storage of Plastic Waste have also to be made, at ULB level, by the Municipal Commissioners so that the Cement Plants can take away the collected/stored waste, at required intervals, once the desirable quantities of Plastic Waste are accumulated at ULBs.
- 6. The Regional Director-cum-Appellate Commissioners of Municipal Administration, Rajamahendravaram, Guntur and Anantapuram are requested to coordinate with the managements of the Cement Plants and guide the Municipal Commissioners in tie-up with them and send compliance report to this office by 11th of September, 2019.
