**UPON hearing the counsel the Court made the following
O R D E R**

- 1 In pursuance of the previous order dated 6 January 2023, a meeting was convened by Mr Justice A M Sapre, Chairperson of the Supreme Court Committee on Road Safety. The minutes of the meeting are appended to the note which has been submitted by Mr Gaurav Agrawal, *amicus curiae*.
- 2 The Committee has drawn up a road map for taking steps for the implementation of Section 136A of the Motor Vehicles Act 1988.
- 3 One of the suggestions of the petitioner pertains to the need for the inclusion of National Highways Authority of India (NHAI) in the framework for implementing Section 136A, having due regard to the large number of accidents which take place on national highways.
- 4 The above aspect may be taken note of by the Chairperson of the Committee so that appropriate directions can be issued for including NHAI within the framework, if found necessary.
