**ORDER**

1. By filing the present application, the applicant has prayed as follows:

*“a. Pass an order directing Respondent No.6, Collector Surat to initiate immediate action to close down and dismantle all the commercial illegal coastal shrimp farms on the floodplains and within the CRZ areas along the Tapi and Mindhola River/ Estuary and coastline in Village Damka, Village Rajgiri, Village Junagam, (Shivrampur), Village Aabhva, Village Dumas, Village Khajod, Village Budiya, Village Gabheni, Village Talangpor, Village Umber, Village Jiyav and elsewhere in Choryasi Taluka, Surat District, Gujarat and confiscate the DG Sets, Aeration systems, water intake & disposal pipeline network, machinery, equipment and other infrastructure installed without authorization and requisite permits during the pendency and final decision of the OA.*

*b. Pass an order to recover the cost of dismantling unauthorised/illegal shrimp farmers in and along the Tapi and Mindhola River/ Estuary and in coastal Villages of Choryasi Taluka, Surat District, Gujarat from the occupier/owner/operator of the unauthorised/illegal shrimp farms.”*

2. Issue notice to the respondents. Returnable within four weeks.
3. Applicant is directed to take required step for service to the respondents by both ways, Dasti as well as by Registered Post and also send the required documents by available e-mail.
4. Respondents are directed to reply or file counter within six weeks by e-mail at [judicial-ngt@gov.in](mailto:judicial-ngt@gov.in) preferably in the form of searchable PDF/ OCR Support PDF and not in the form of Image PDF.
