UPON hearing the counsel the Court made the following
O R D E R

On the last date of hearing, we had made clear to the parties that this is a fit case where we will have to appoint a third party expert agency to ascertain whether a compliance has been made by the appellant with the directions issued by the National Green Tribunal. In addition, the agency so appointed will have to verify whether the appellant has made substantial compliance with the Solid Waster Management Rules, 2016 and the Bio Medical Waste Management Rules, 2016.

For the aforesaid three purposes, we hereby appoint National Environmental Engineering Research Institute (NEERI) having office at Nehru Marg, Nagpur-440020, Maharashtra.

The Learned senior counsel appearing for the appellant has placed on record e-mail addressed by the Senior Principal Scientist of NEERI to the appellant.

In view of what is stated in the e-mail, we grant time of two weeks to NEERI to make site visit and assess the quantum of work and necessary charges. As soon as the necessary communication is submitted by NEERI to the

appellant, the requisite amount shall be paid by the appellant to the NEERI within two weeks of the date of receipt of the communication.

We direct the appellant to place on record the further communications issued by NEERI and further steps taken by the appellant within a period of five weeks from today. The appellant shall forward a copy of this order to NEERI.

List the matter on 22nd September, 2023 for reporting compliance.
